Re: Notice of Cease and Desist

To Whom It May Concern:

The Office of the Arkansas Attorney General (“OAG”) is the state’s chief consumer advocate and law enforcement officer. To fulfill these duties, the OAG is empowered to investigate business practices and to enforce consumer protection laws where violations exist.

Recently, the OAG received information indicating that Dreamscape Networks International is the registrant of the domain LifeEasyOnPills.org, a website that facilitates the sale of medical pills that induce abortions to consumers in Arkansas. The OAG independently reviewed this website and verified the allegation.

Abortions are prohibited in Arkansas pursuant to Ark. Code Ann. § 20-16-1304, *et seq.* except for specific, extenuating circumstances. Moreover, Ark. Code Ann. § 20-16-1504 specifically makes it a crime “to provide any abortion-inducing drug via courier, delivery, or mail service.” Consequently, abortion pills may not legally be shipped to Arkansas.

Furthermore, LifeEasyOnPills.org states that these abortion pills, “can safely be used for up to 8 weeks.” A recent study, however, found that “real-world insurance claims data for 865,727 prescribed mifepristone abortions” shows “a serious adverse event rate of 10.93 percent.” Jamie Bryan Hall & Ryan T. Based on this information, it appears that some of LifeEasyOnPills.org’s business practices may constitute false, deceptive, and unconscionable trade practices under the Arkansas Deceptive Trade


Practices Act, Ark. Code Ann. § 4-88-101, *et seq* (“ADTPA”). The Attorney General of Arkansas demands that you **CEASE AND DESIST IMMEDIATELY** from hosting websites conducting or facilitating sales of abortion products to the state of Arkansas. If you refuse to comply, a formal investigation will be initiated. Additionally, the Attorney General may bring a lawsuit against you for violations of the ADTPA. If successful, you may face civil penalties up to \$10,000 per violation.

To avoid further action, please notify the OAG of the steps you have taken to remedy this situation within 14 days of the date of this letter. Your response should be in writing and addressed to:
