Meeting: Arkansas Feral Hog Eradication Task Force - Fall Meeting

Date: October 31, 2024

Location: Hybrid (In-person and Virtual)

1. Call to Order: The Natural Resources Division called the meeting to order. The recording was initiated, and attendees were welcomed. Ryan was noted to be delayed due to traffic, and several members joined virtually.

- Emphasis on the importance of community engagement and public reporting in identifying feral hog activity.
- Review funding opportunities to support eradication efforts and potential grants for 2025 initiatives.

- Follow up on interagency collaboration for future eradication strategies.
- Document and share findings from Colorado's presentation.
- Explore grant opportunities and funding mechanisms to enhance future control programs.
