Applications for Arkansas Department of Agriculture Funding are currently closed. Applications will reopen with the finalization and call for applications for the Water & Sewer Treatment Facility Grant Program (State Matching Grant).

Applicants are encouraged to complete steps 1 through 5 below to be in the best position when the applications reopen. All projects to be considered for funding must also be on the relevant Project Priority List (PPL).

Standard Department funding application process

1. The first step in applying for Department funding is completing and submitting either a Drinking Water or Clean (waste) Water PPL application. To receive funding, a project must be on the relevant PPL. To be added to the relevant list you can visit the Project Priority Lists, Intended Use Plans, and Reports page <https://agriculture.arkansas.gov/natural-resources/water-development/water-and-wastewater-funding/project-priority-lists-intended-use-plans-and-reports/>, scroll to State Revolving Fund Priority List and then click the appropriate “here” to open the form. We suggest you add all projects that you may wish to fund in the next five years to the relevant PPL, regardless of the funding source you plan to utilize.

2. The second step in our funding process is to complete a Water & Wastewater Advisory Committee (WWAC) pre-application, the committee meets monthly to review applications. After this committee reviews the project pre-application, WWAC will make a recommendation in writing on the funding source. You are welcome to submit a Department funding application along with the WWAC if you elect to pursue Department funding. Email the WWAC application to AGRI.wwac@arkansas.gov

WWAC pre-applications are due by COB the 15th of every month to be placed on the next month's agenda. The pre-application is available on the Water and Wastewater Funding webpage by scrolling to Forms and Resources at the bottom of the page:

3. The third step for the Department funding application process is that all water and sewer projects must complete the state required water plan compliance review. 4. The fourth step is to request an EnABLE account to access our new web-based system. Scroll down to Forms and Resources and click on the EnABLE User Access Form link to download the form. Applicants can request to set up their EnABLE account at any time. Additional user access forms will be needed if the recipient is approved and accepts an Department loan to set permission for users on the project level.

5. The fifth and final step is to submit a Department funding application via the EnABLE account that was created in step 4. We recommend downloading the guidance document located in the upper right-hand corner of the screen and looks like an open book. Click on this icon and it will begin to download.
