Arkansas Hemp Program Summary of Varieties List

PUBLICATION DATE: 12/2025

Approved license holders should review this document before purchasing seed or plant propagules/seedlings for the growing season. This document provides important guidance for licensed growers based on past THC laboratory test results from hemp grown in Arkansas. Provided here is a list of *Varieties of Concern*, as well as all other varieties that have been grown and tested in Arkansas in the past three (3) seasons. Any variety or strain of hemp not listed in this document requires the submission of the **New Variety Request Form** and pre-approval from the Department before it can be grown in Arkansas.

Hemp is defined in federal law as “the plant *Cannabis sativa L.* and any part of that plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol [THC] concentration of not more than 0.3 percent on a dry weight basis.” The measurement of the THC concentration includes both delta-9 THCa and delta-9 THC (often referred to as Total THC).

Hemp Program Rules, Section 1(A) provides the following definitions:

- (3) **“Approved cultivar”** means any variety of industrial hemp designated by the Arkansas State Plant Board in a published list and may be amended from time to time.
- (32) **“Prohibited Variety”** means a variety or strain of cannabis excluded from the Department’s Industrial Hemp Research Program.
- (43) **“Variety of Concern”** means any variety of hemp in the Program that tests above 0.3% total delta-9-THC in one (1) or more pre-harvest samples from diverse locations and production conditions. A hemp variety designated as a “variety of concern” may be subject to restrictions and additional testing. Materials testing at a total delta-9-THC concentration above 0.3 percent may be subject to law enforcement action.

Approximately 100% of all hemp produced in Arkansas is for Phytocannabinoid/floral production, but fiber and grain markets are becoming more popular. Phytocannabinoids are a broad class of chemicals produced primarily in the floral material of the plant; these include THC and other compounds of nutraceutical interest such as Cannabidiol (CBD) or Cannabigerol (CBG). Current scientific research suggests that phytocannabinoids have proportional relationships. Therefore, as growers strive to increase the plant’s CBD or other phytocannabinoid production, there is concern about the potential increase of THC levels. The Department remains committed to managing its Program so that it produces hemp that meets the legal definition of “hemp” in Hemp Research Program Rules, Section 1(A)(14). To that end, the Department publishes this list to help hemp growers plan their future activities in the Hemp Program. **Be advised that virtually all high-CBD strains of hemp have the potential to test above the legal limit of THC if allowed to fully mature.**

Varieties of Concern (VOC)

The varieties or strains designated as a *Variety of Concern* (VOC) in the table below had at least one (1) THC test result above 0.300%. Growers who are considering whether to use these varieties in the future should exercise caution and remain aware of the Department's *Varieties of Concern* and *Prohibited Variety* designations. These varieties are at higher risk for exceeding the THC limit that could lead to the ordered destruction of the crop. These designations are subject to change. **NOTE: If you wish to grow a variety that has been determined by the Department to be a *Variety of Concern*, proceed with caution, and make sure to monitor your THC levels regularly once your crop begins maturing.**

Prohibited Varieties

The varieties or strains of cannabis designated as *Prohibited Varieties* in the table below have been prohibited from use in Arkansas. This designation was made in accordance with the latest *Sampling, Testing, Remediation & Disposal Guidelines* which is incorporated by reference into Program Rules and outlined below.

A variety or strain of cannabis may be designated as a *Prohibited Variety* and excluded from the Arkansas Hemp Program if:

- a) more than 50% of Pre-Harvest Samples' test results for a given *Variety of Concern* are above 0.300% delta-9-THC,
- b) a Pre-Harvest test result is equal to or greater than 1% delta-9-THC, or
- c) a Post-Harvest test result is equal to or greater than 0.400% delta-9-THC.

For Varieties determined to be a Prohibited Variety:

- a) The Department may report the existence of a Prohibited Variety to relevant state and federal law enforcement agencies, and
- b) a License Holder must surrender without compensation any viable seed, live plants, stock plants, and all germplasm, shall be destroyed in the presence of a Department representative, law enforcement, or both.

New Varieties

The varieties or strains designated as *NEW* in the table below have been approved for entry into the Arkansas Hemp Program based on an out-of-state certificate of analysis, but the variety has not yet been grown or tested in Arkansas. These varieties are eligible to be grown in Arkansas without additional submissions of the *New Variety Request Form*, but their performance in Arkansas remains untested.

Additional Varieties/Strains

The varieties or strains listed in the table below without a designation produced acceptable THC test results and therefore are not currently designated as a *Prohibited Variety* or *Variety of Concern*.
