Tier 1 Categorical Exclusion

After appropriate environmental review, it has been determined that the subject jobs are a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Programmatic Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for these projects.

The purpose of these proposed projects is to preserve and rehabilitate deteriorating pavement on state highways. The attached table lists the projects, their locations, and type of work. Project location maps are attached.

The projects would not involve relocations or impacts to Important Farmland, wetlands, underground storage tanks, hazardous materials, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxics concerns. A Section 404 permit is not required. Cultural resource clearances are attached.

The attached official species lists obtained through the U.S. Fish and Wildlife Service (USFWS) Information for Planning and Consultation website identified the following species as potentially occurring within the project areas: Gray Bat (*Myotis grisescens*), Indiana Bat (*Myotis sodalis*), Northern Long-eared Bat (*Myotis septentrionalis*), Ozark Big-eared Bat (*Corynorhinus townsendii ingens*), Tricolored Bat (*Perimyotis subflavus*), Eastern Black Rail (*Laterallus jamaicensis* ssp. *jamaicensis*), Ivory-billed Woodpecker (*Campephilus principalis*), Piping Plover (*Charadrius melodus*), Rufa Red Knot (*Calidris canutus rufa*), Red-cockaded Woodpecker (*Dryobates borealis*), Alligator Snapping Turtle (*Macrochelys temminckii*), Ozark Hellbender (*Cryptobranchus alleganiensis bishopi*), Yellowcheek Darter (*Etheostoma moorei*), Fat Pocketbook (*Potamilus capax*), Pink Mucket (*Lampsilis abrupta*), Rabbitsfoot (*Theliderma cylindrica*) and Rabbitsfoot Designated Critical Habitat, Scaleshell Mussel (*Potamilus leptodon*), Snuffbox Mussel (*Epioblasma triquetra*), Speckled Pocketbook (*Lampsilis streckeri*), Western Fanshell (*Cyprogenia aberti*), Winged Mapleleaf (*Quadrula fragosa*), pondberry (*Lindera melissifolia*), Missouri Bladderpod (*Physaria filiformis*), American Burying Beetle (*Nicrophorus americanus*), and Monarch Butterfly (*Danaus plexippus*).

The projects would have “no effect” on the aforementioned species and Designated Critical Habitat due to the limited scope of the action, lack of suitable habitat, and distance to known species locations.

The Alligator Snapping Turtle is currently a proposed threatened species; the Monarch Butterfly is a proposed threatened species, and the Tricolored Bat is a proposed endangered species. The proposed projects would not jeopardize the continued existence of any of these species.

A Coordination Letter to the National Park Service and a copy of Water Pollution Control Special Provision, due to the proximity of the East Fork of Cadron Creek on Job A00094, were submitted on September 18, 2025.

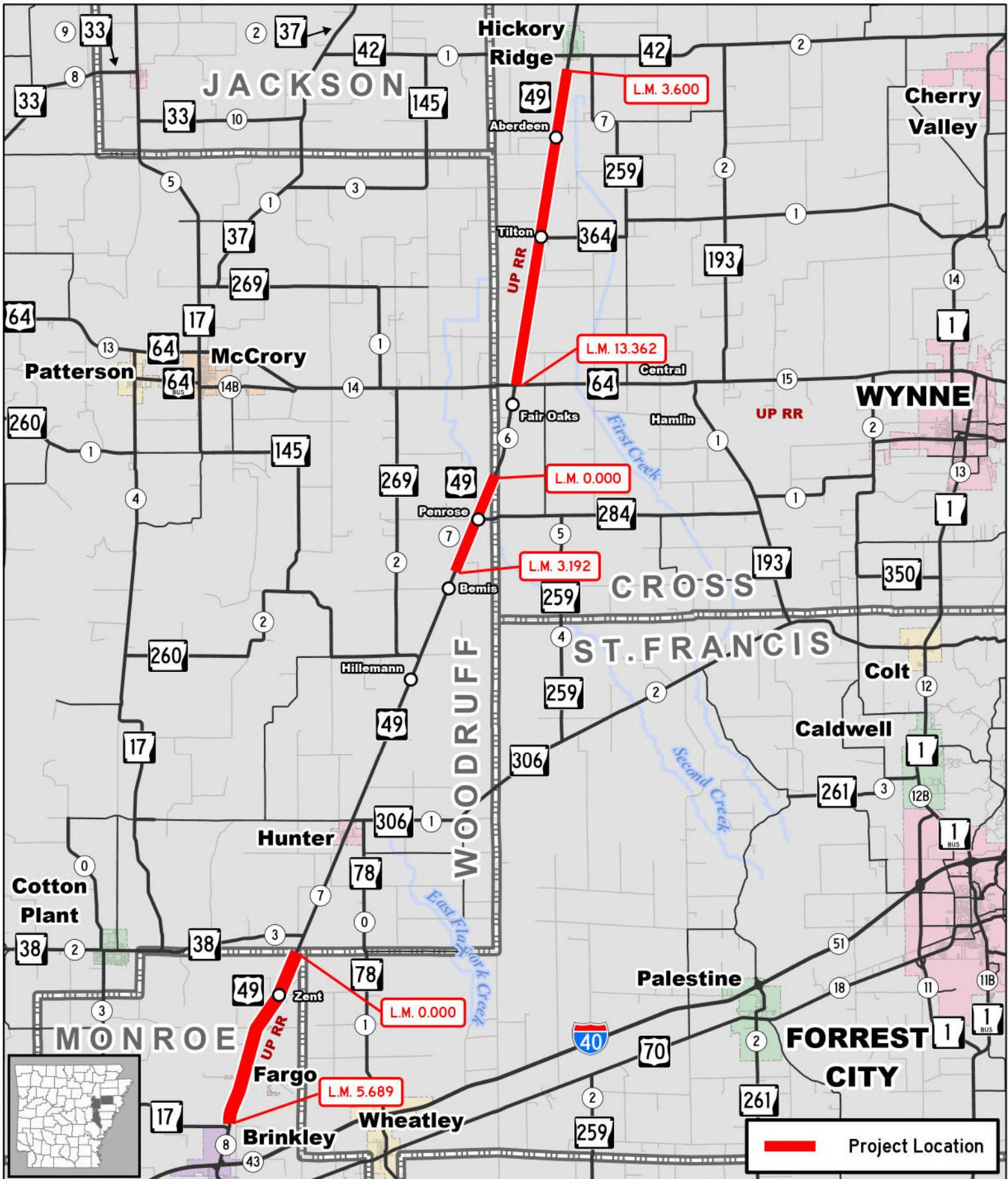
These projects would not have a discharge of dredged or fill material into waters of the United States; therefore, a Section 404 permit will not be required.

The 1853 GLO plat shows a road from Brownsville to Duval's Bluff crossing the project area. The 1851 GLO plat shows a field, a 'road from Pigeon Roost,' and a 'Road from Little Rock to Des Arc' near the project. No cultural indicators were found on the 1852 GLO plat near the project. The 1936 Lonoke and Prairie County General Highway and Transportation maps show several structures along the existing highway.

All work will be within the existing ROW, and the limited scope of the project occurs within previously disturbed areas (highway construction). Therefore, this project requires no Section 106 review under Appendix B, Activity 2, of the 2024 Amended Programmatic Agreement.

A records check at the Arkansas Archaeological Survey shows two sites (3RA0418 and 3RA0466) near the proposed project, but they will not be affected by this undertaking. The review of the Arkansas Historic Preservation Program's (AHPP) structure database shows one historic structure (RA0091) near the project. Property RA0091, the Rice-Upshaw House, is listed on the National Register of Historic Places, but will not be impacted by this undertaking. ARDOT Bridges X0758, M1675, M1676, M1677, 03241, and 03254 are within the project area, but will not be impacted. No cultural indicators were found on the 1829 General Land Office plat, the 1936 Randolph County General Highway and Transportation road map, quadrangle maps, or aerial imagery.

The vertical and horizontal extents, known construction practices, available plans, and contours were examined to assess previous ground disturbance. This type of undertaking has no potential to cause effects to historic properties. All work will be within previously disturbed areas (highway construction).
