**RE: NARTS FFY 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)  
ADMINISTRATIVE MODIFICATION #2 – FFY 2025 AND FFY 2026 FTA 5307 ORT CHANGES**

**ADMINISTRATIVE MODIFICATION DESCRIPTION:**

Through coordination with Ozark Regional Transit (ORT), Arkansas Department of Transportation (ARDOT), and the Federal Transit Administration (FTA), it has been determined that an administrative modification is required to the NARTS FFY 2025-2028 Transportation Improvement Program (TIP), as shown in Exhibit A. This modification moves FTA Section 5307 ORT projects originally programmed in FFY 2025 (NARTS01, 02, 03, and 14) into FFY 2026 to align with FTA grant award timing. No changes to project scope, funding amounts, or project sponsors are proposed.

**NWARPC PUBLIC PARTICIPATION PLAN:**

*Administrative Modifications are revisions that do not require federal approval. If needed for clarification, these revisions to the STIP/TIP may be noted in the comment field on the Federal-aid Project Agreement form. The following identifies applicable revisions to the STIP/TIP that are considered Administrative Modifications.*

1. Change in schedule consistent with 23 CFR 450.218 (n).
2. Modification to the project description / length / termini that does not significantly change the project scope, conflict with the environmental document, or impact transportation conformity in non-attainment areas, subject to coordination with the MPO.
3. A project split or a combination of individually listed projects that do not result in a significant change to the overall scope.
4. For FTA funded projects: a. Funding increases or decreases that are more than 20 percent of the STIP/TIP project estimate, including transfers of eligible funding between projects (e.g., between capital and operating assistance projects). Funding increases or decreases that are less than or equal to 20 percent of the STIP/TIP project estimate require no action; and b. Programming or reprogramming of funding carried over from previous years, including previous STIPs/TIPs, to projects in the current STIP/TIP.
