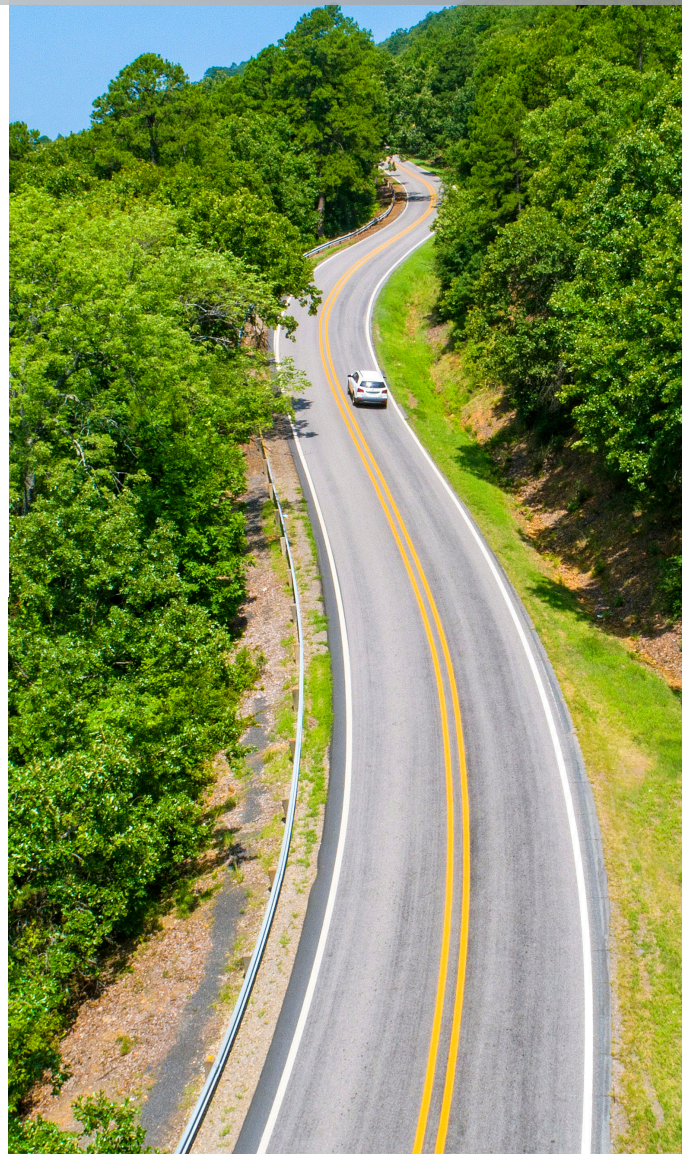

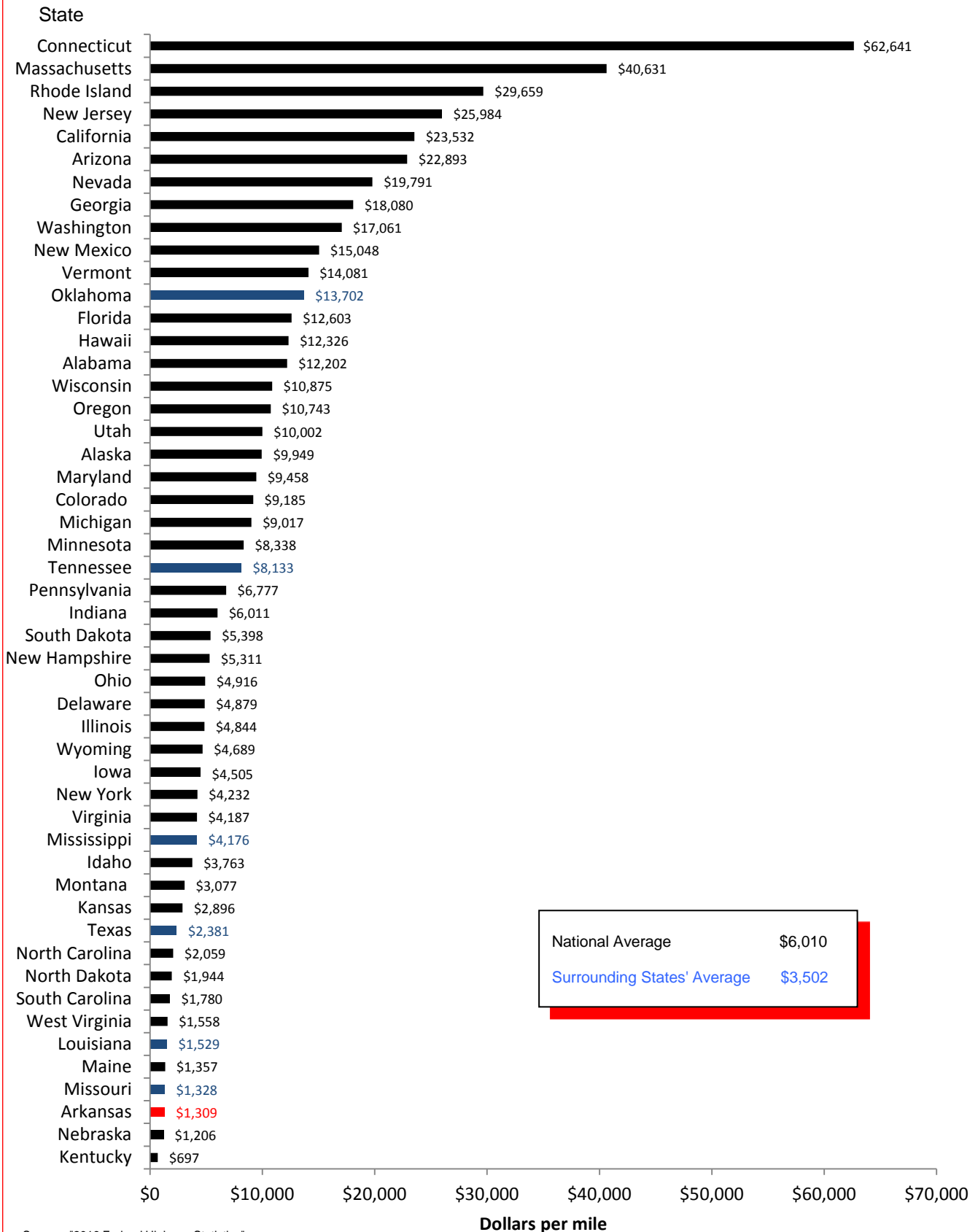

Arkansas Ranks 48th in the Nation

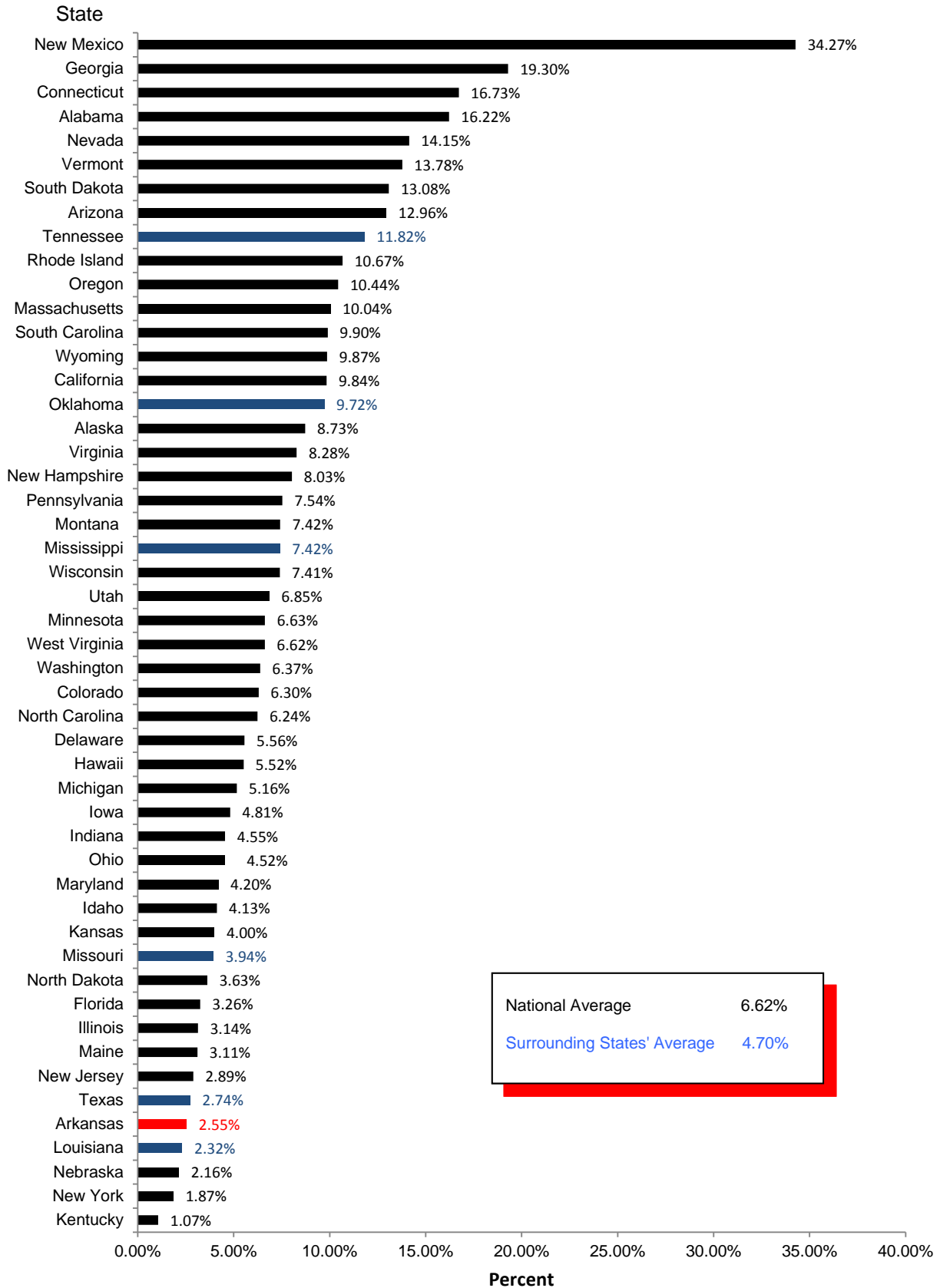

Arkansas Ranks 46th in the Nation

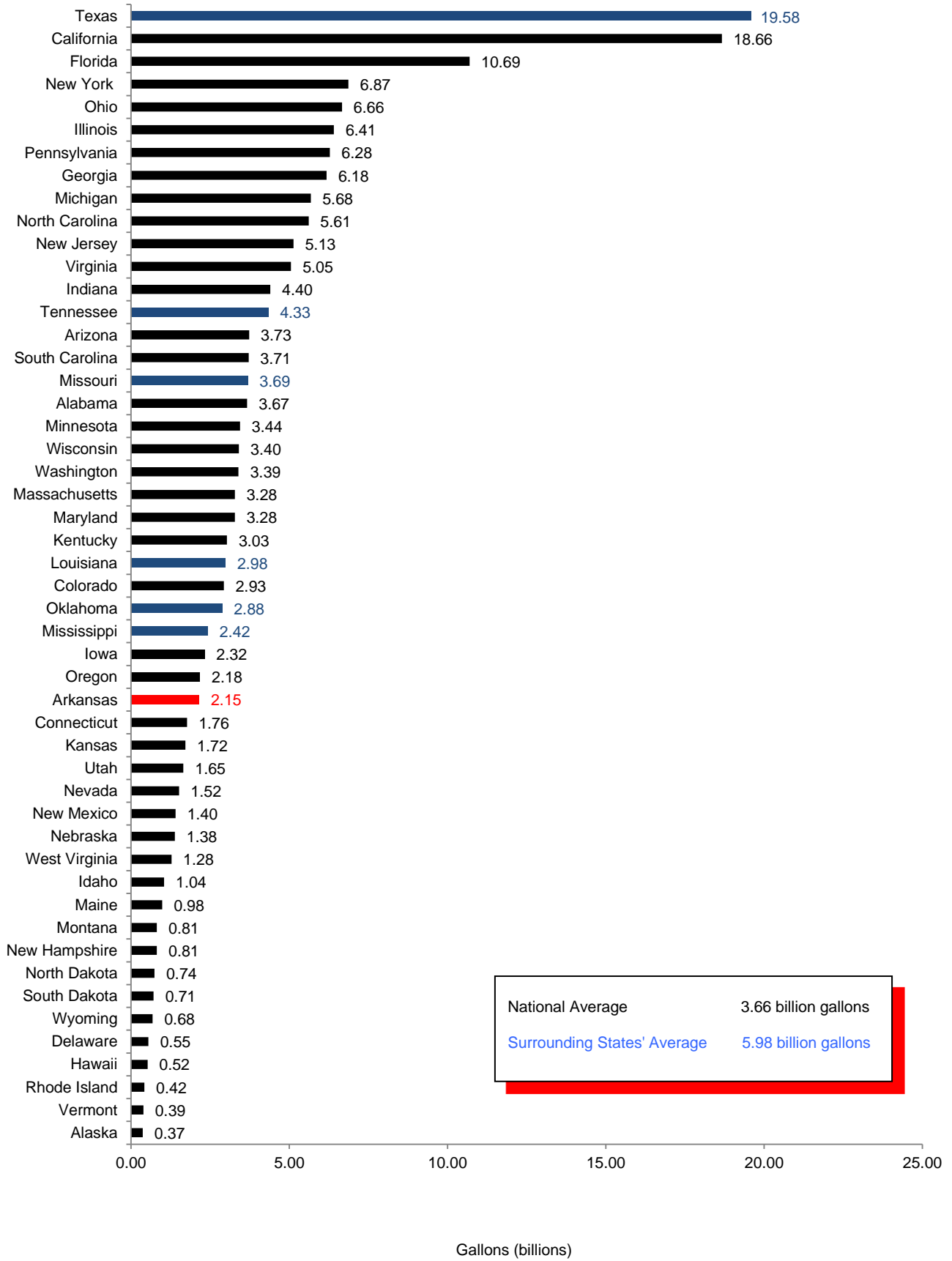

Arkansas Ranks 31st in the Nation

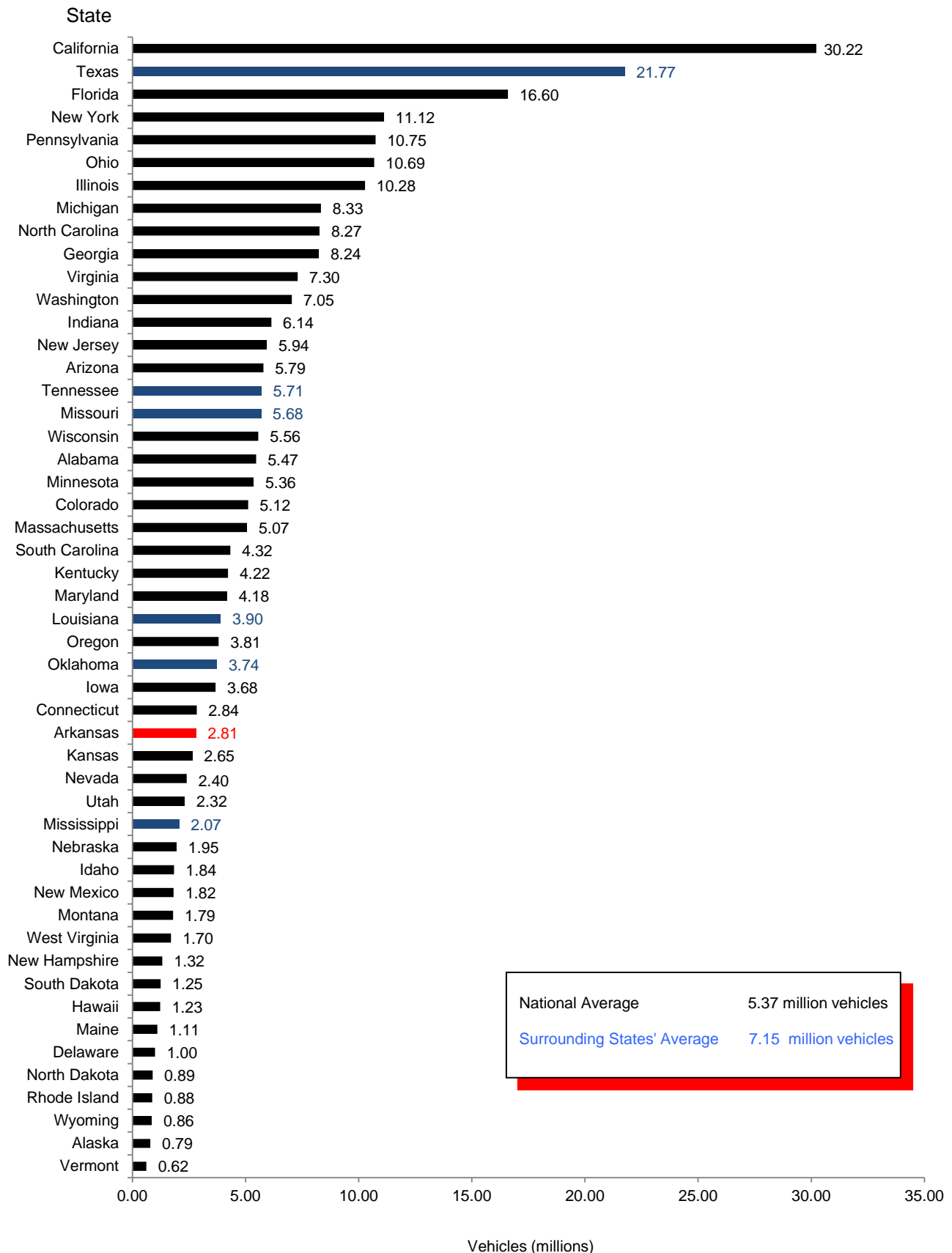

Arkansas Ranks 31st in the Nation

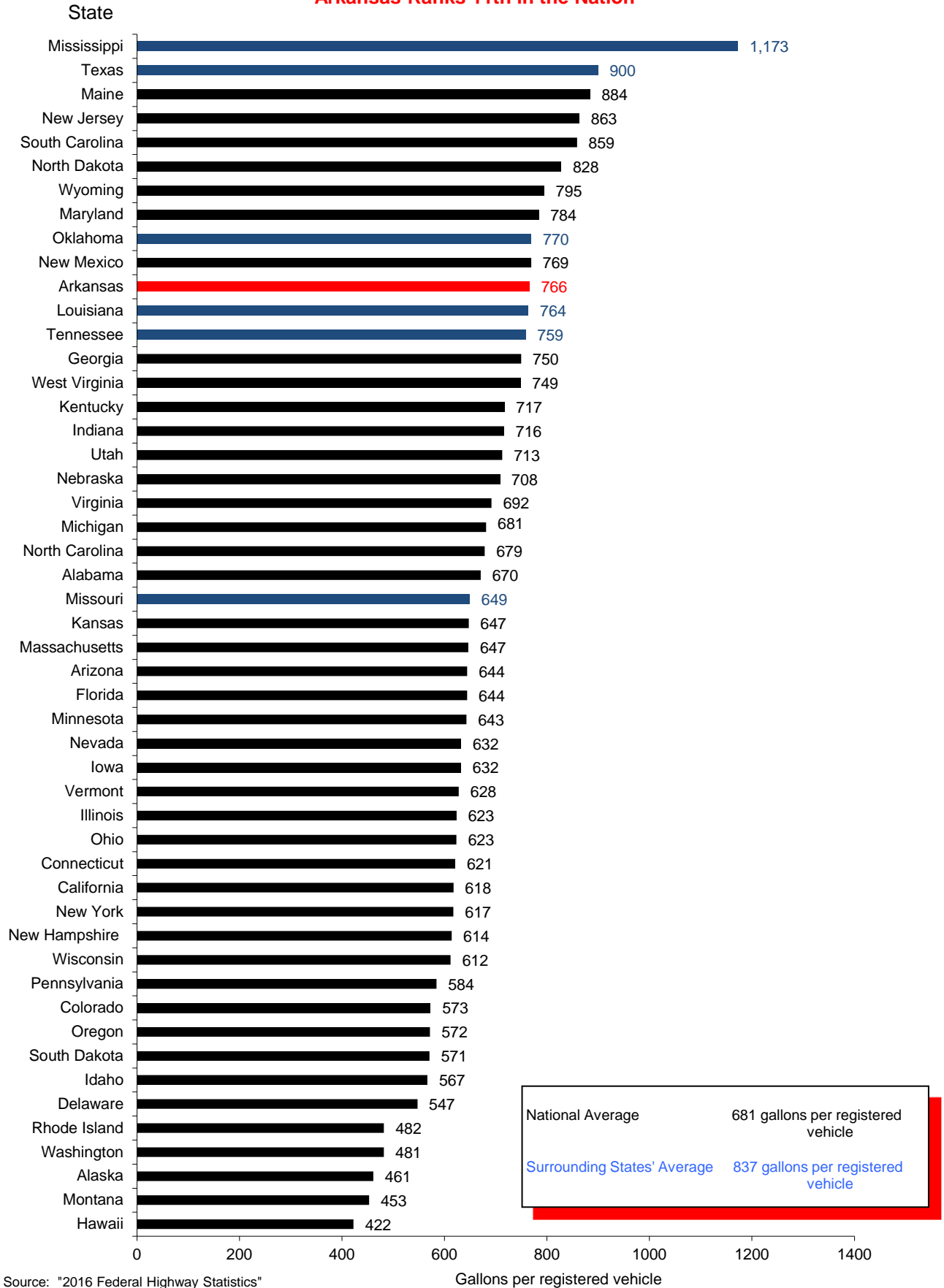

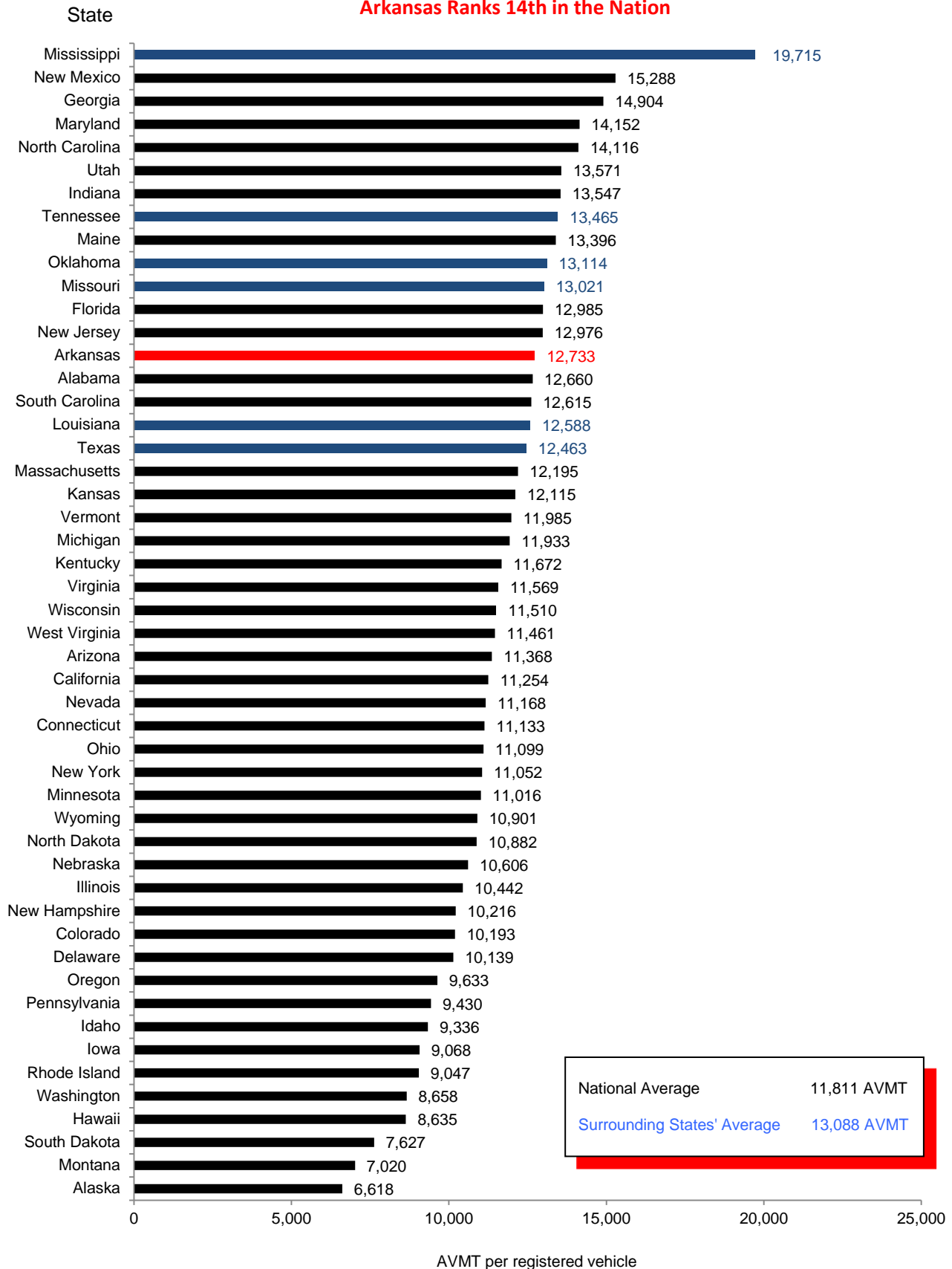

Arkansas Ranks 14th in the Nation

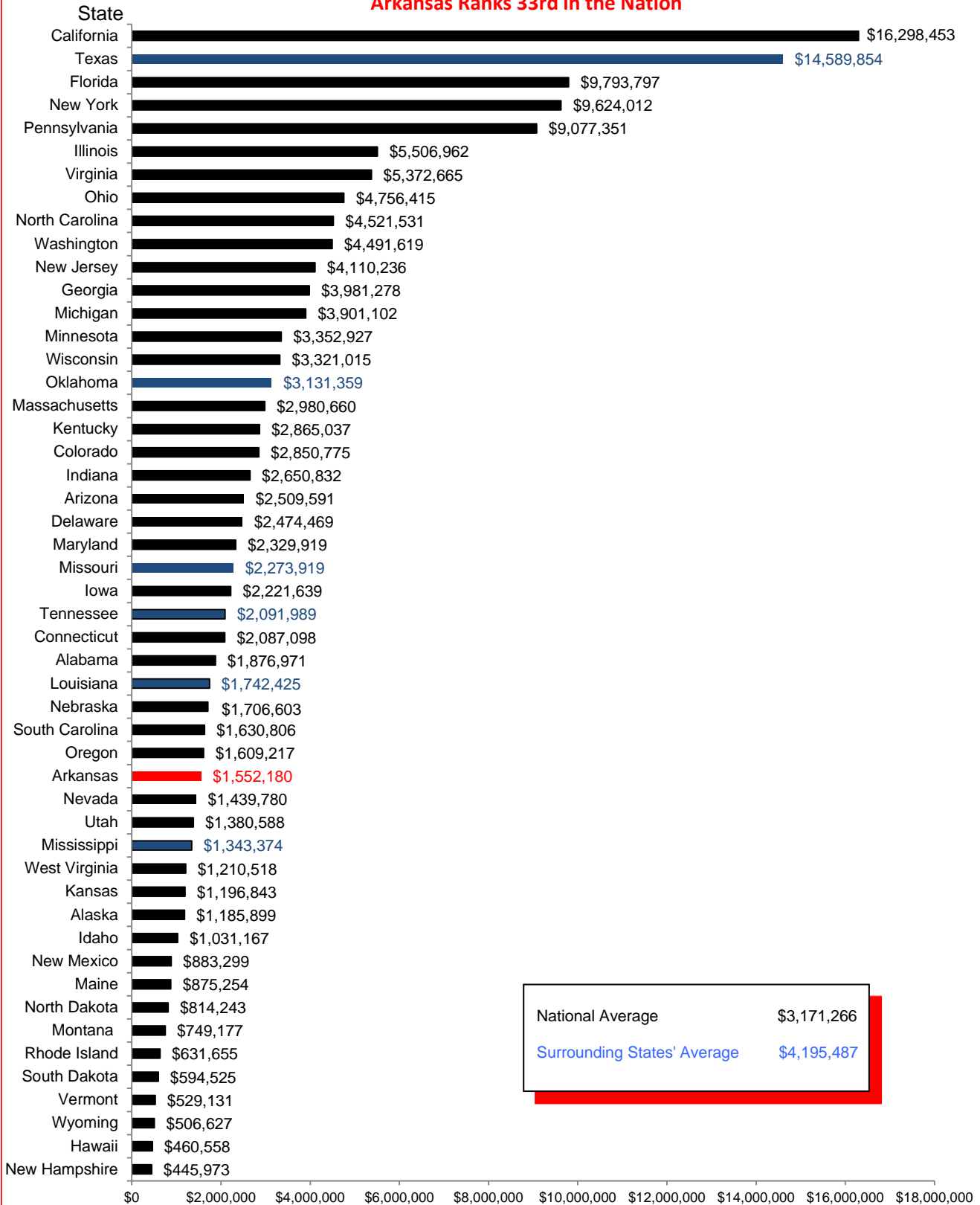

Arkansas Ranks 33rd in the Nation

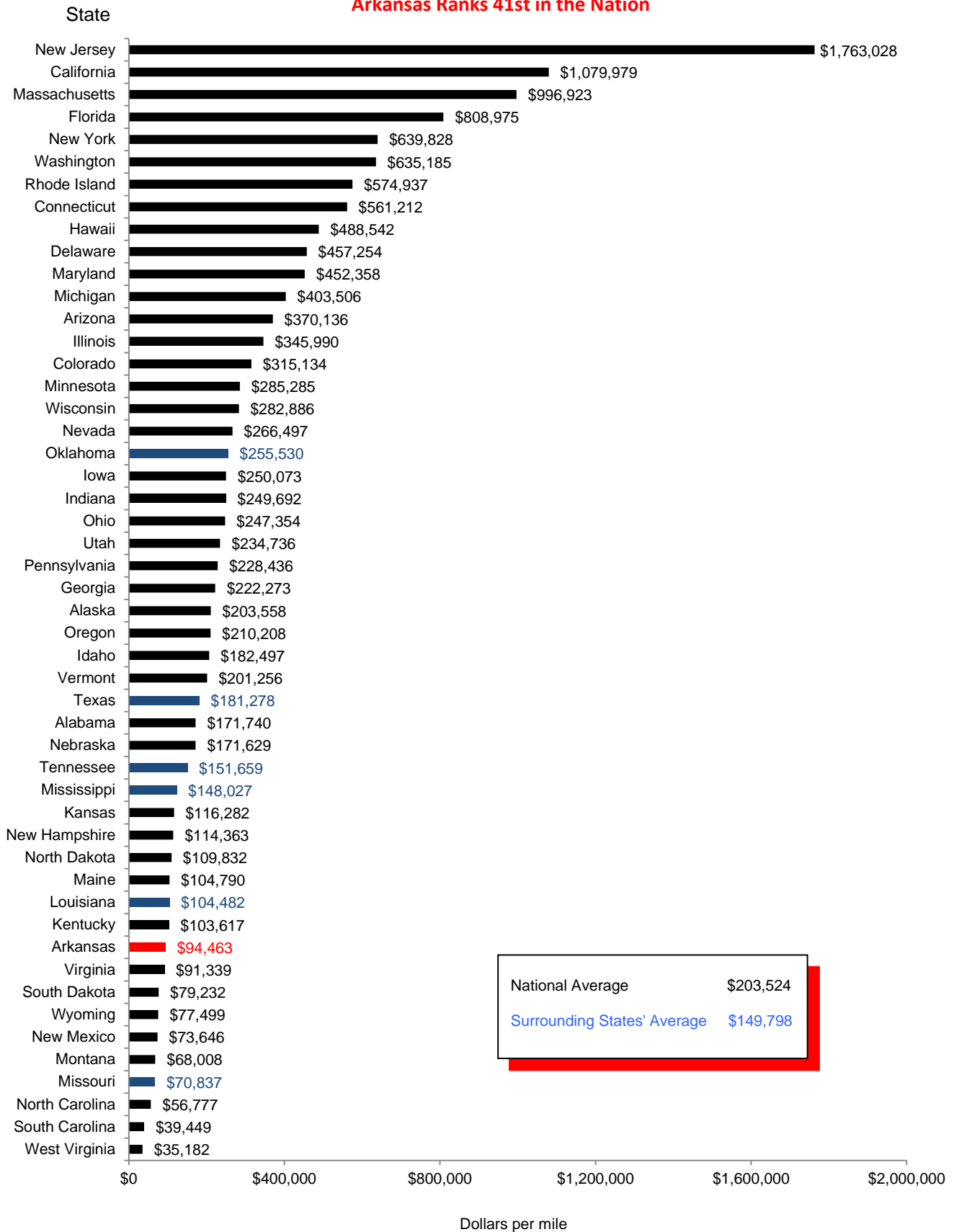

Arkansas Ranks 41st in the Nation



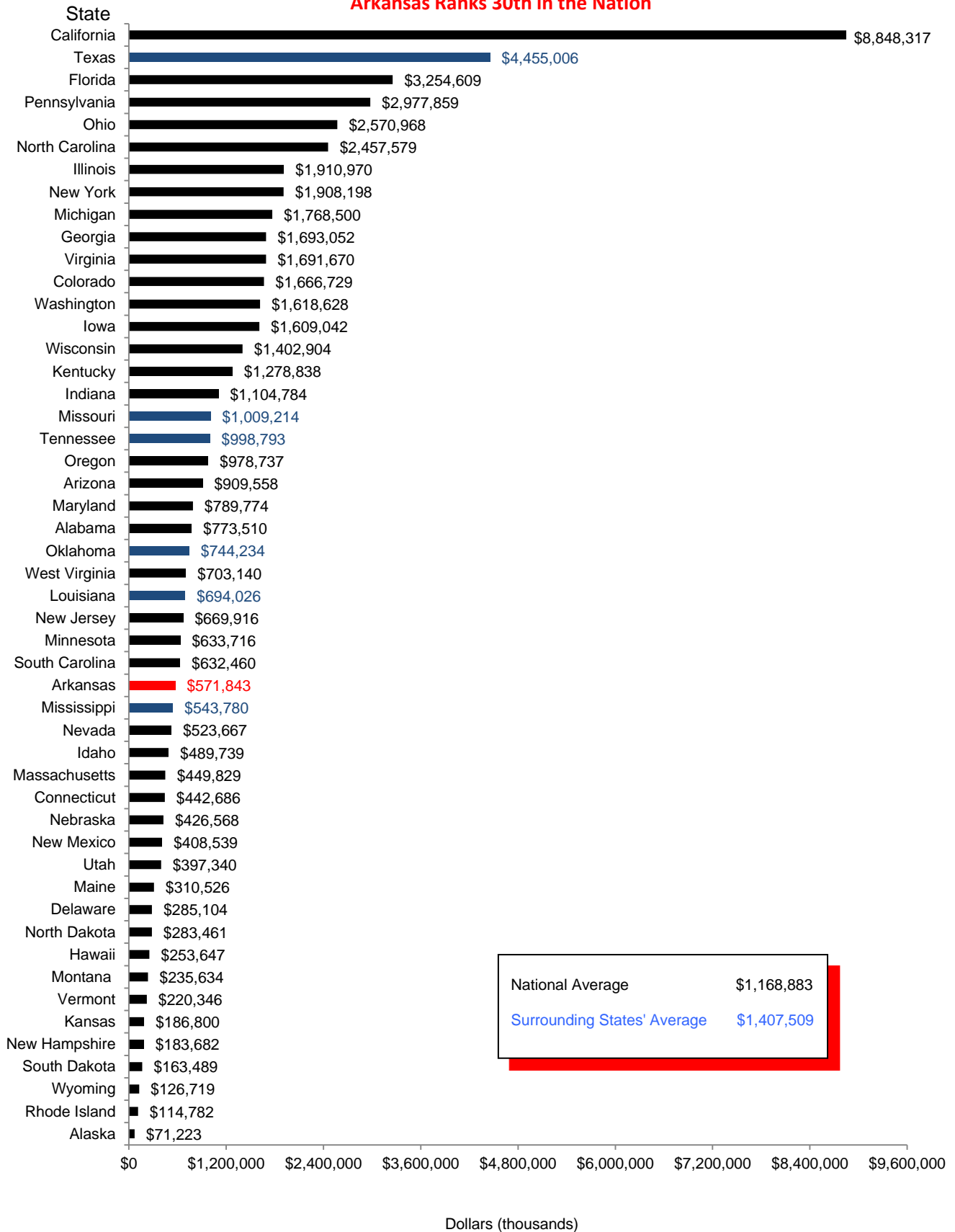

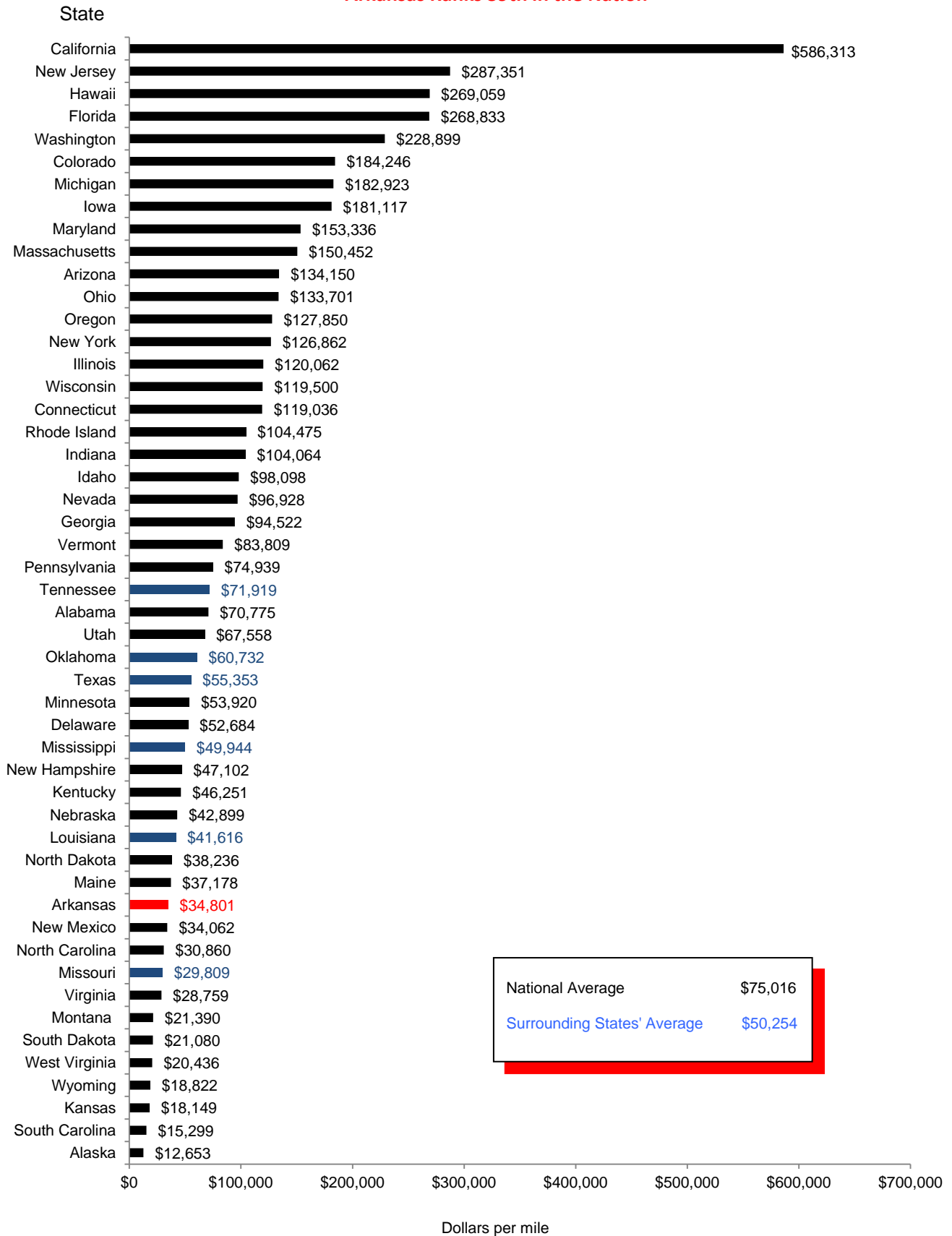

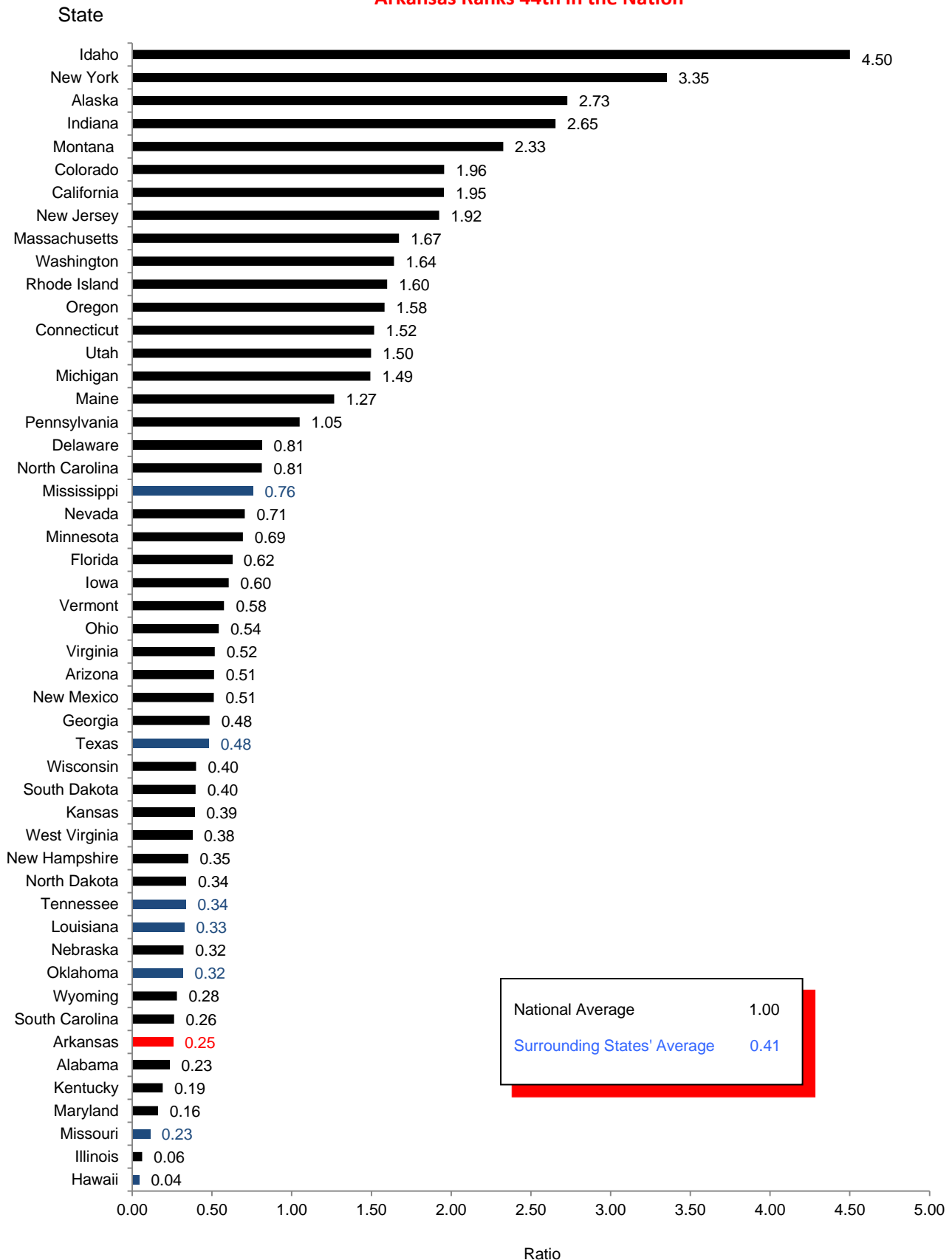

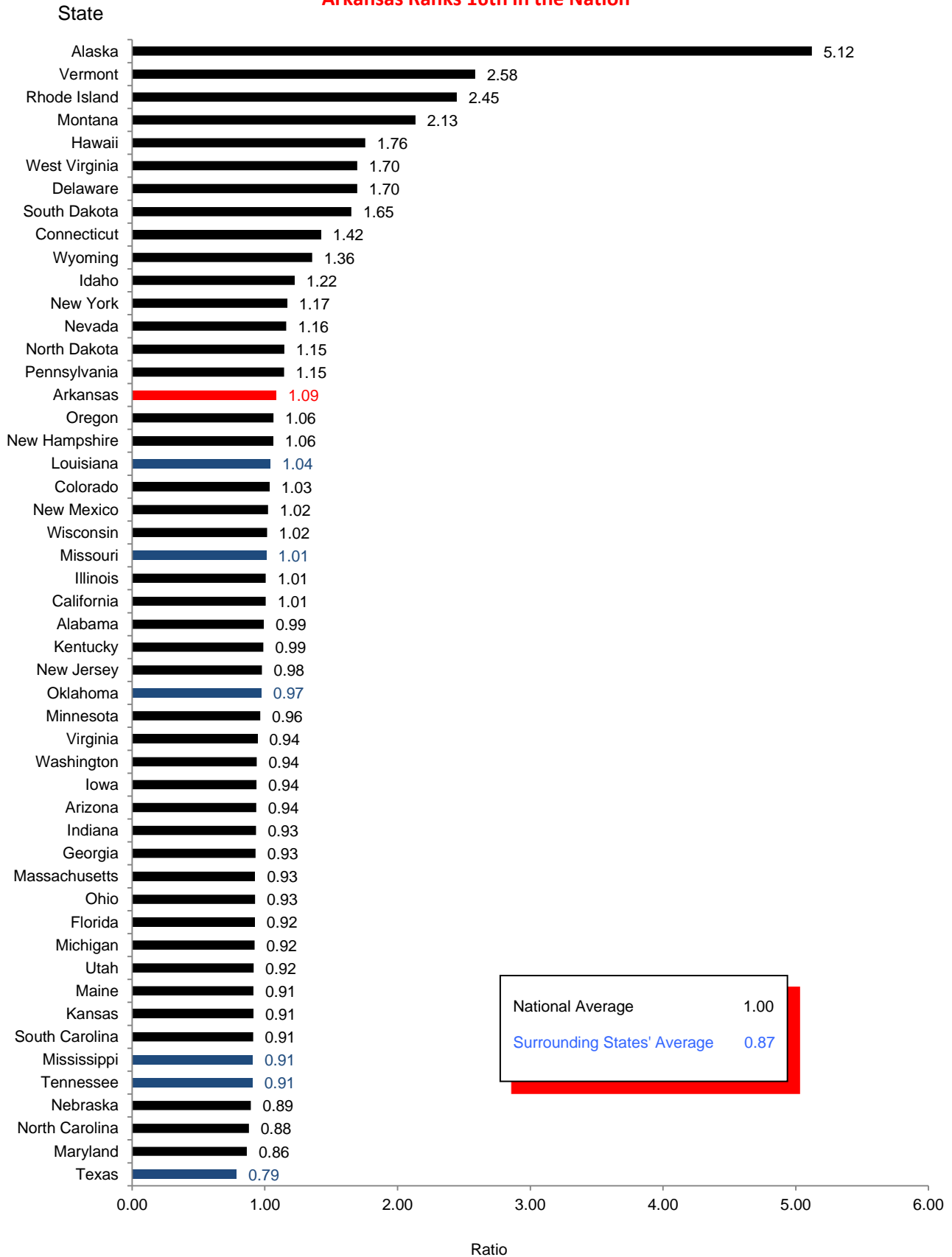

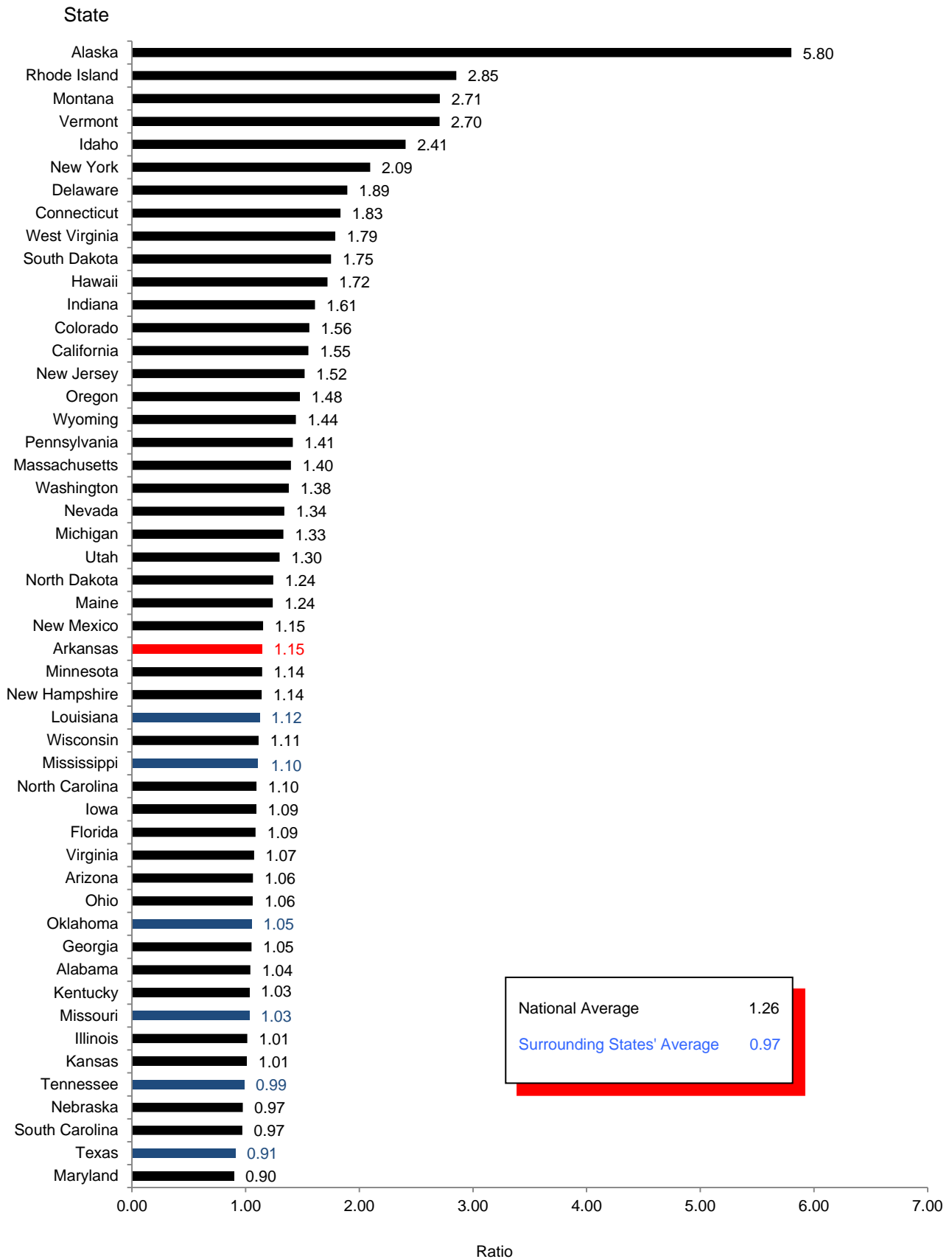

Arkansas Ranks 27th in the Nation

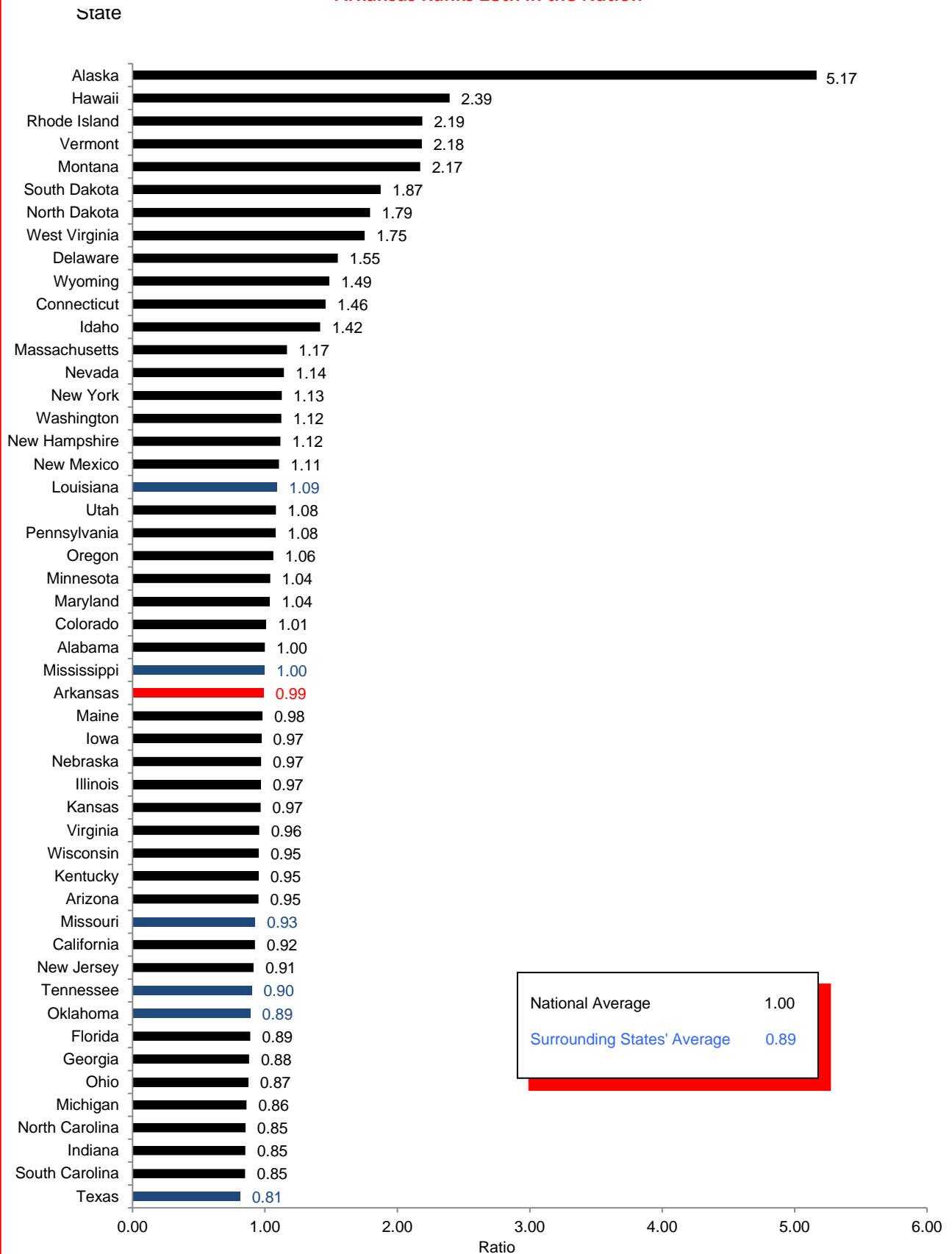

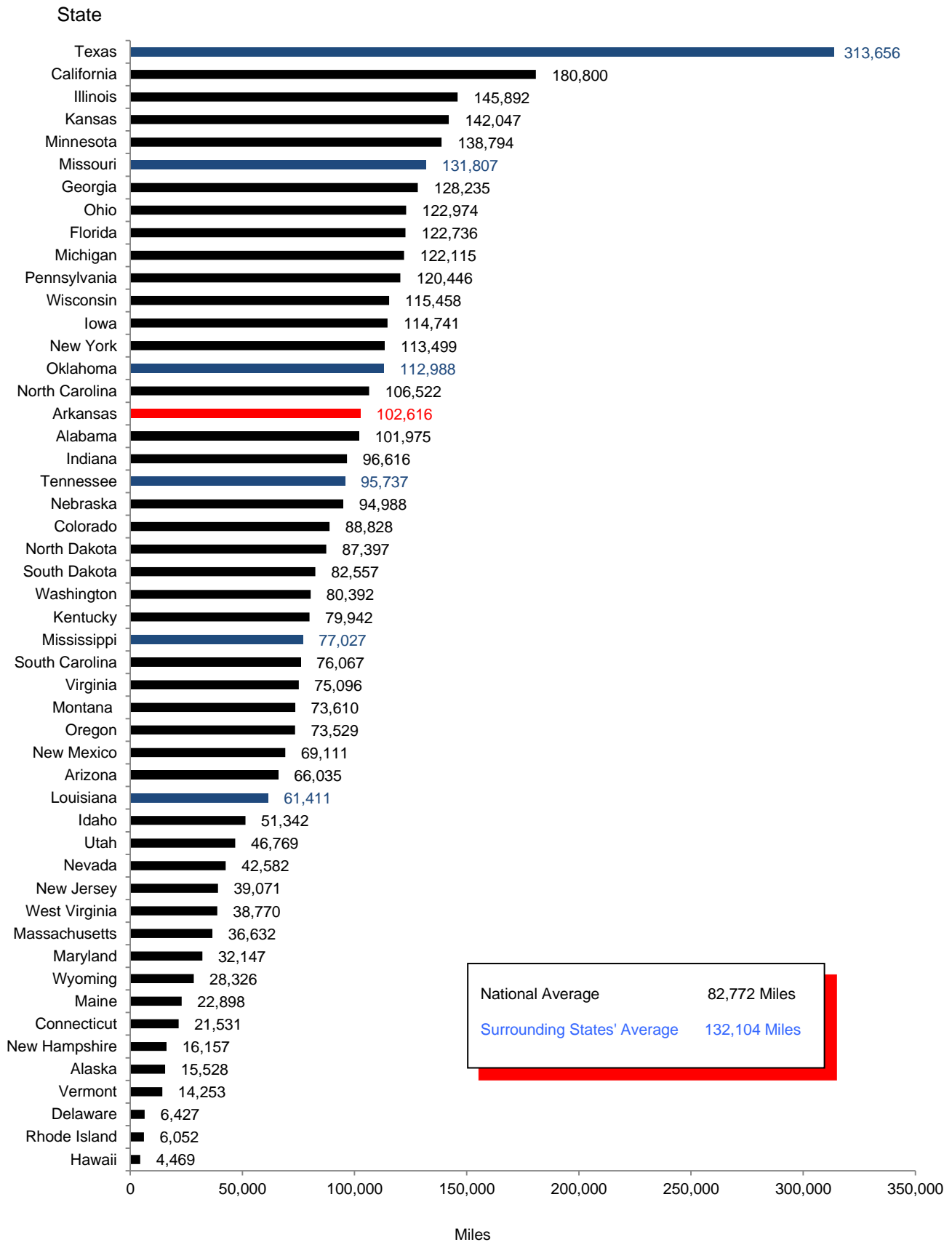

Arkansas Ranks 17th in the Nation

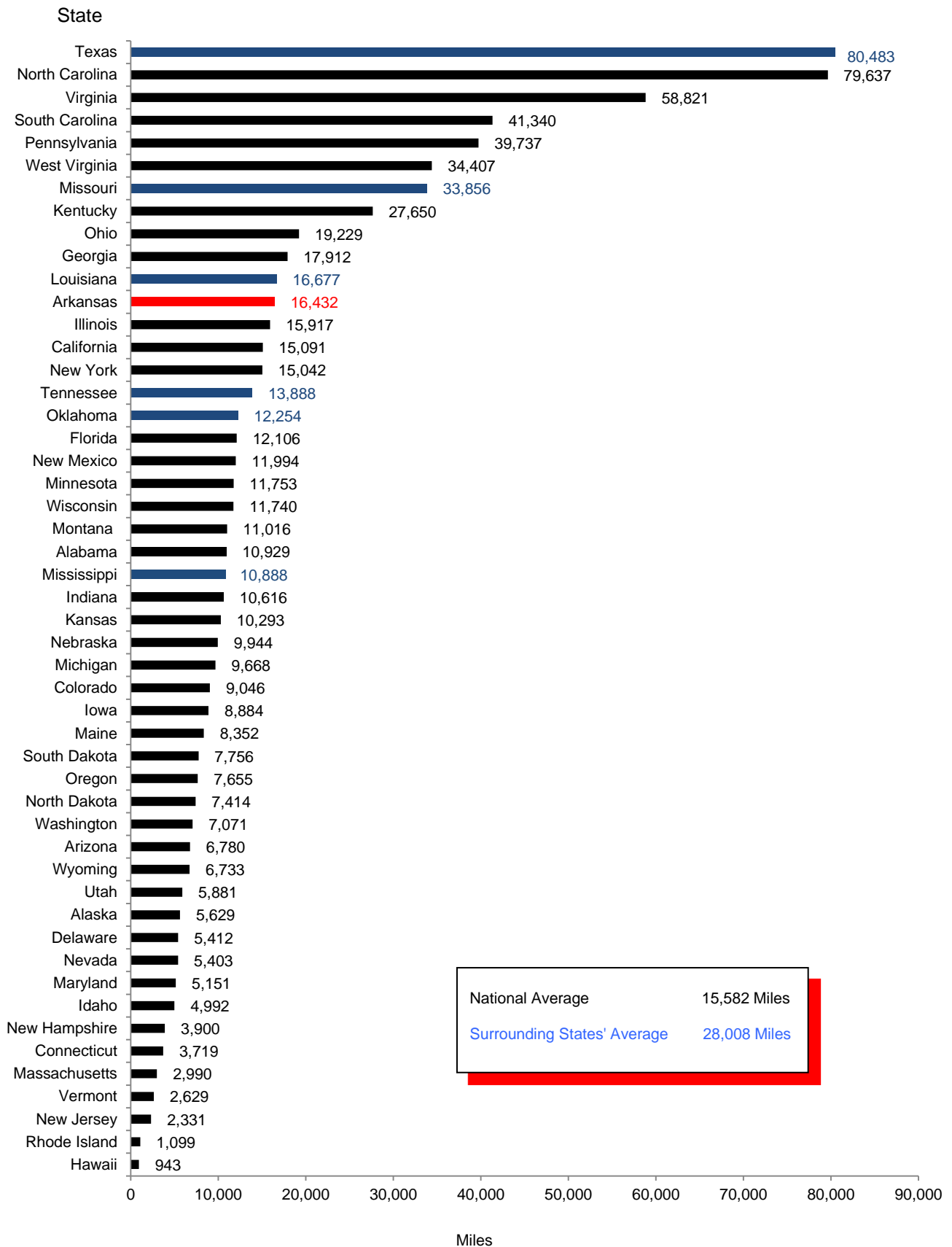

Arkansas Ranks 12th in the Nation

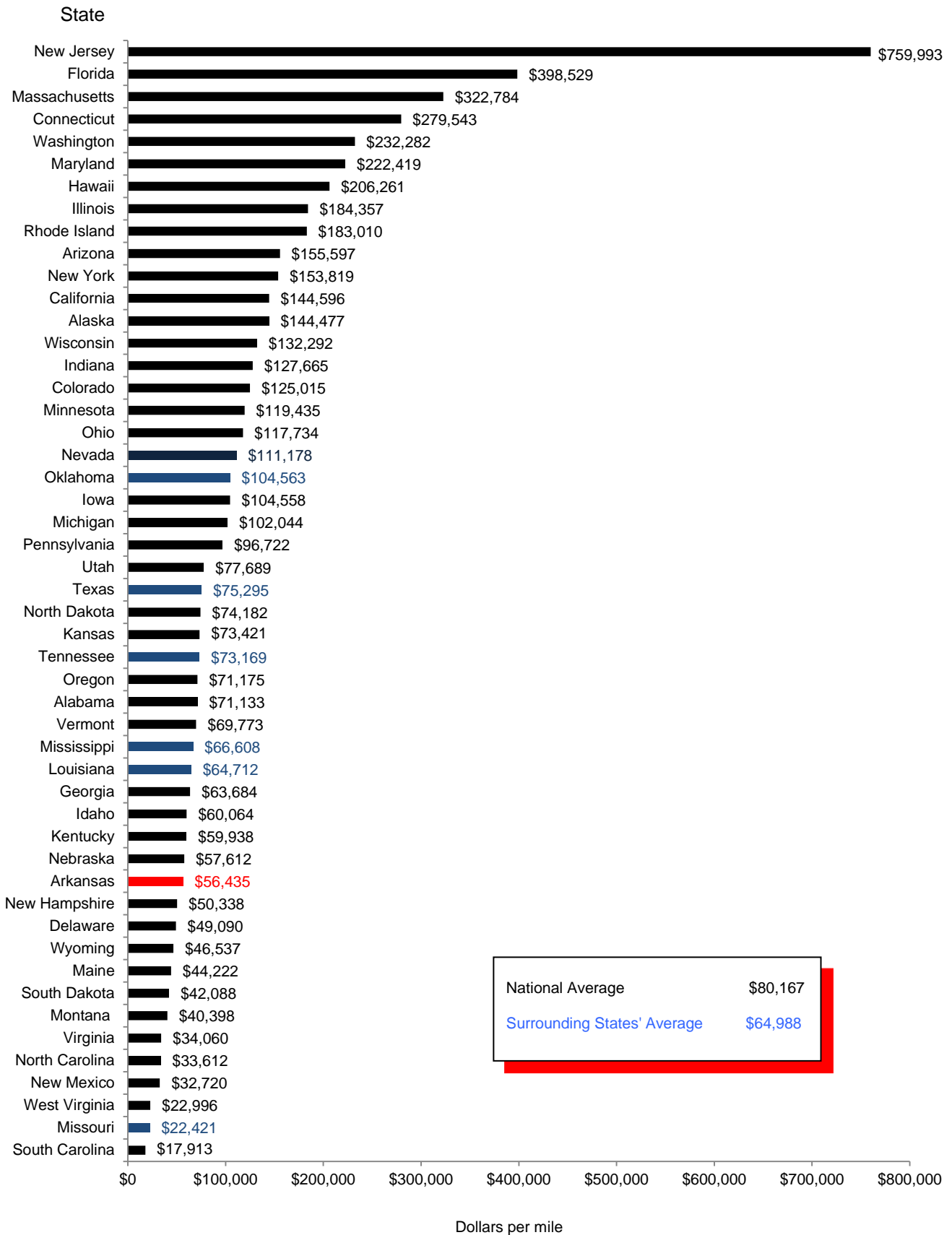

Capital Outlay Disbursements Per Mile

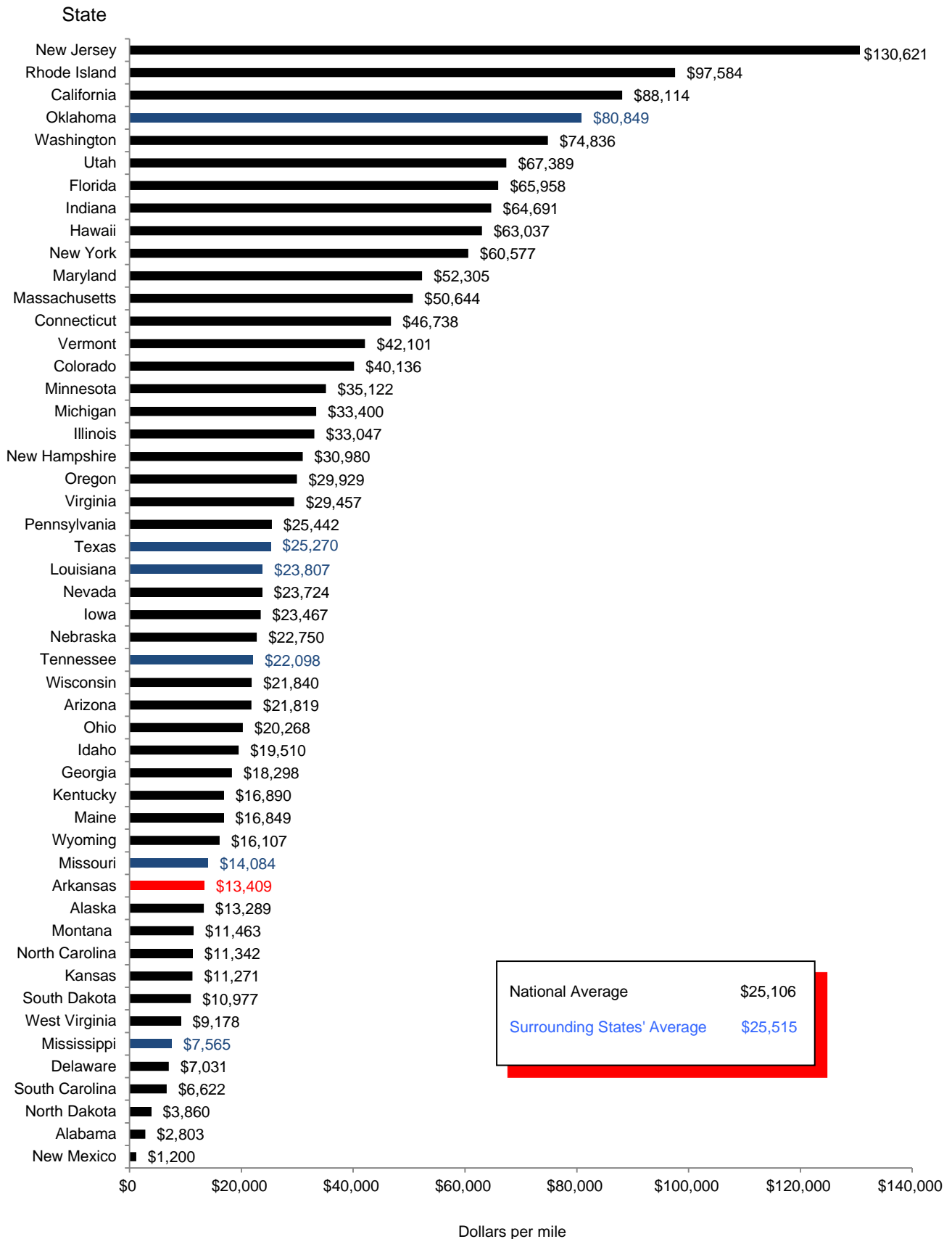

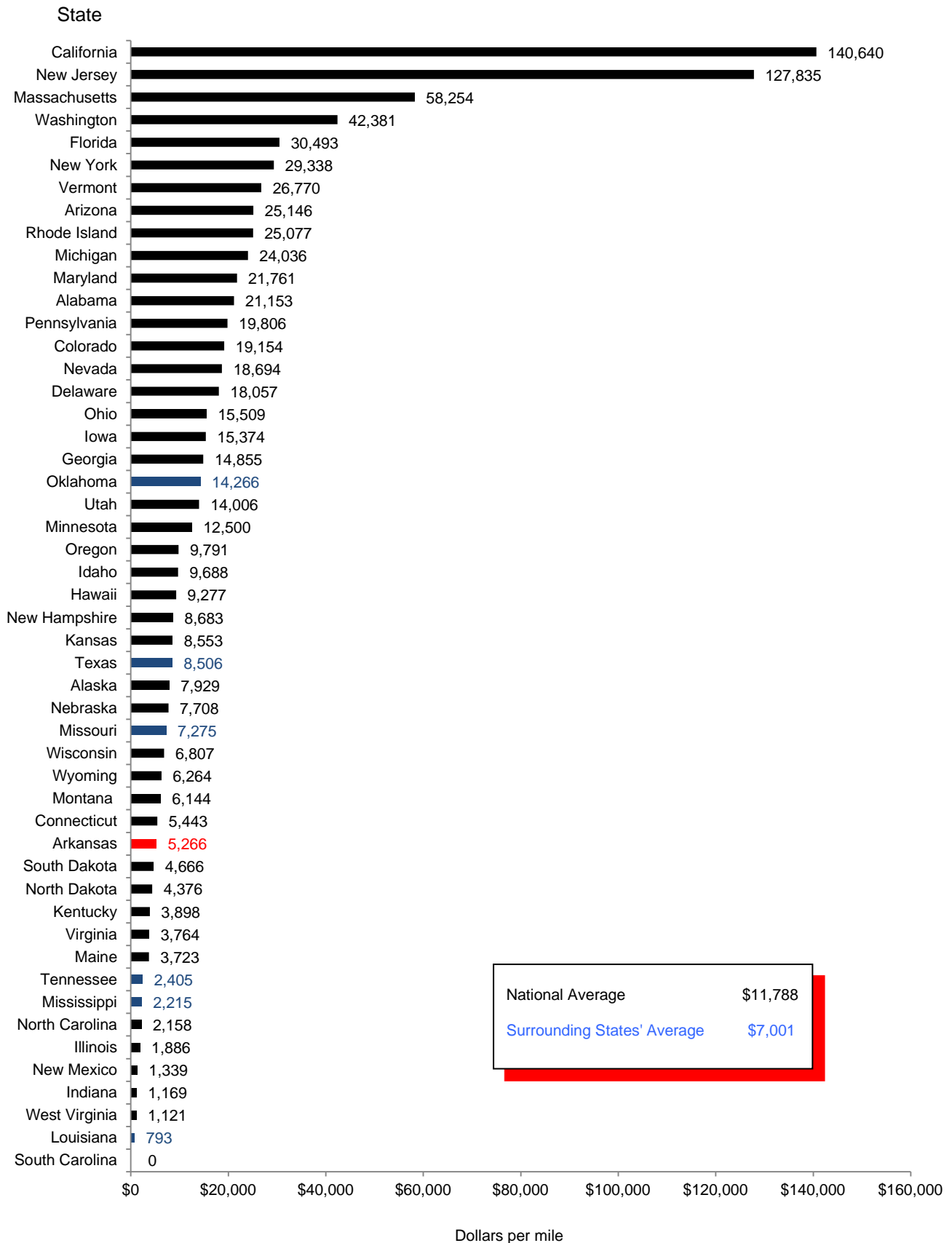

Arkansas Ranks 36th in the Nation

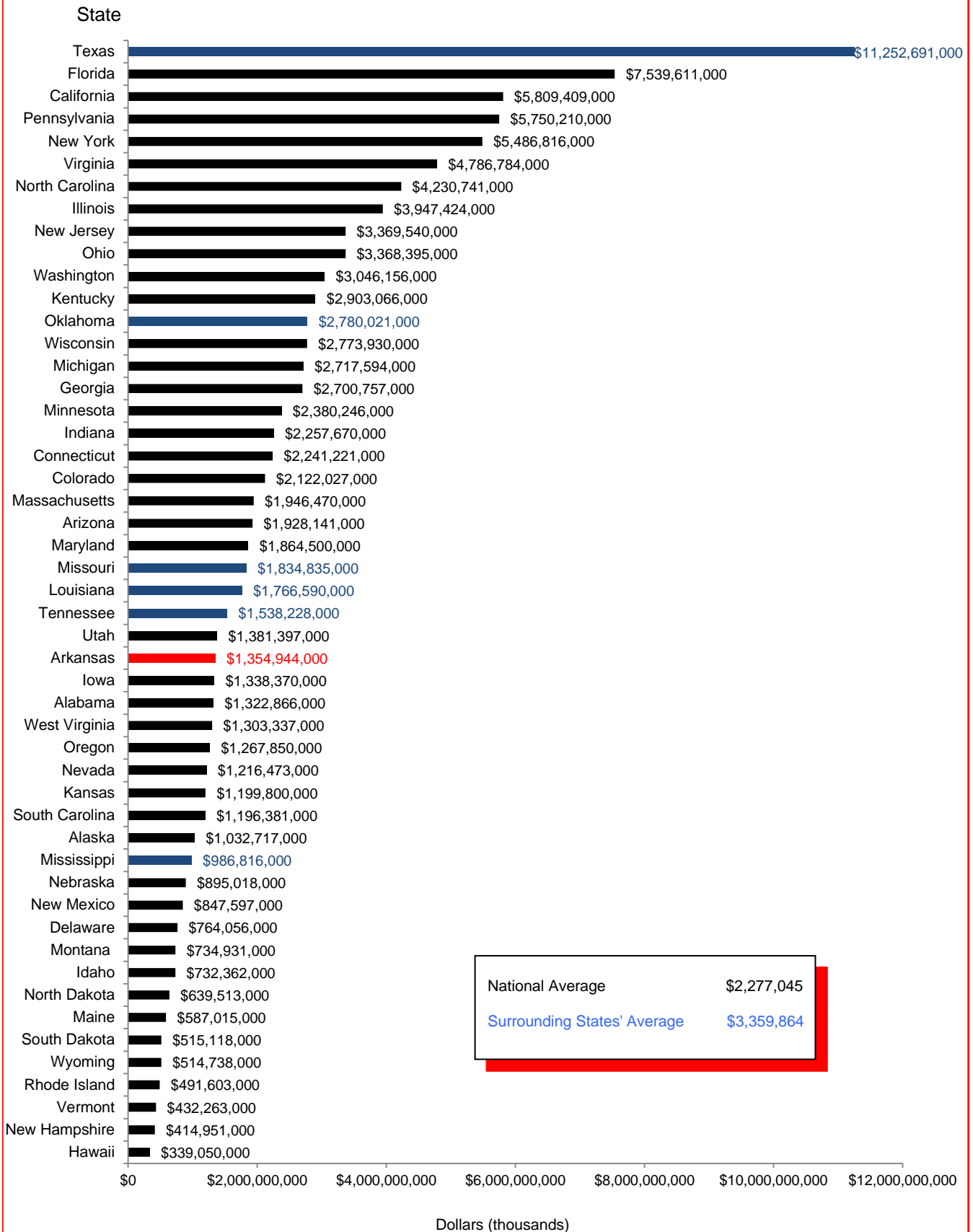

Arkansas Ranks 28th in the Nation

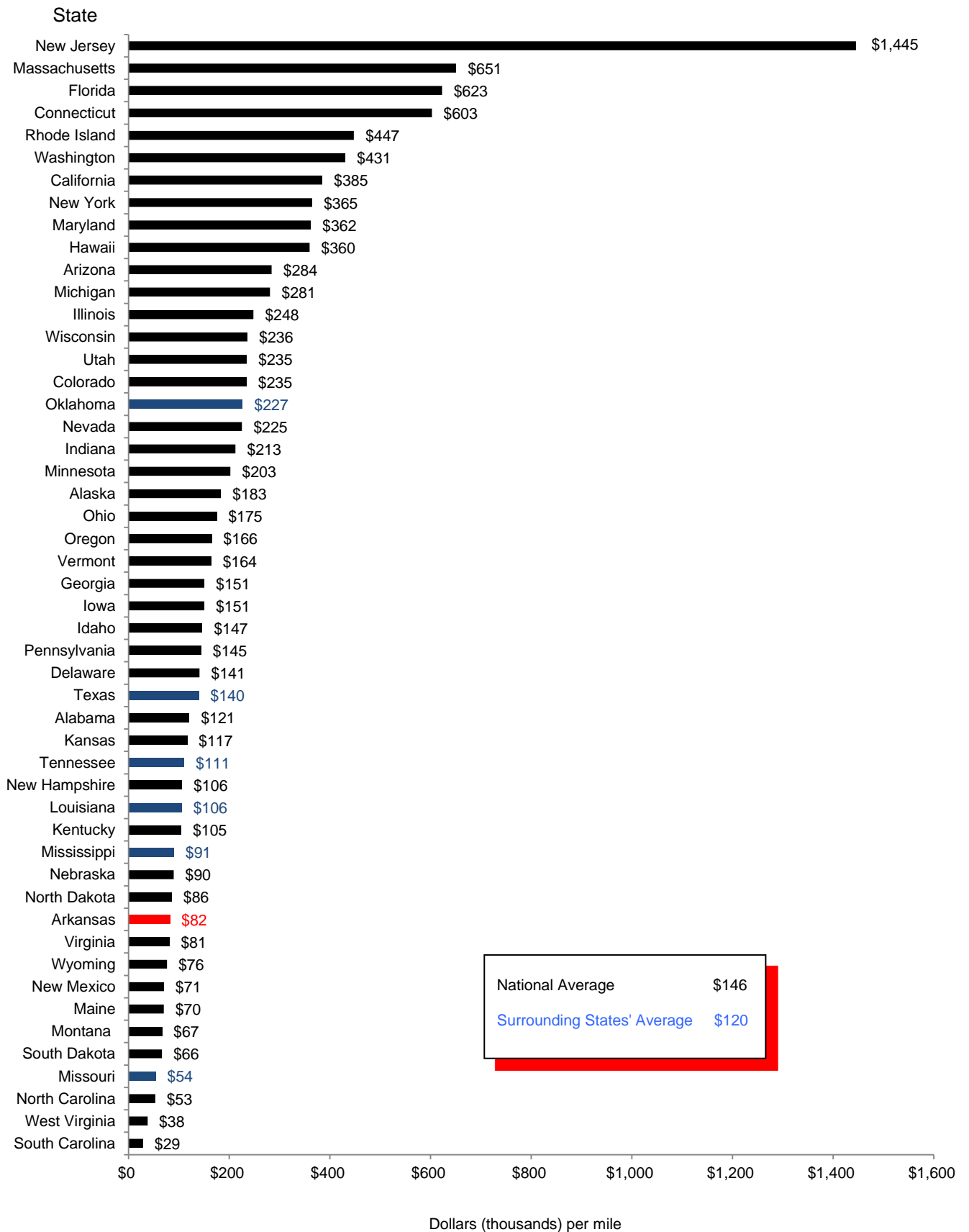

Total Disbursements for State Administered Highways Per Mile

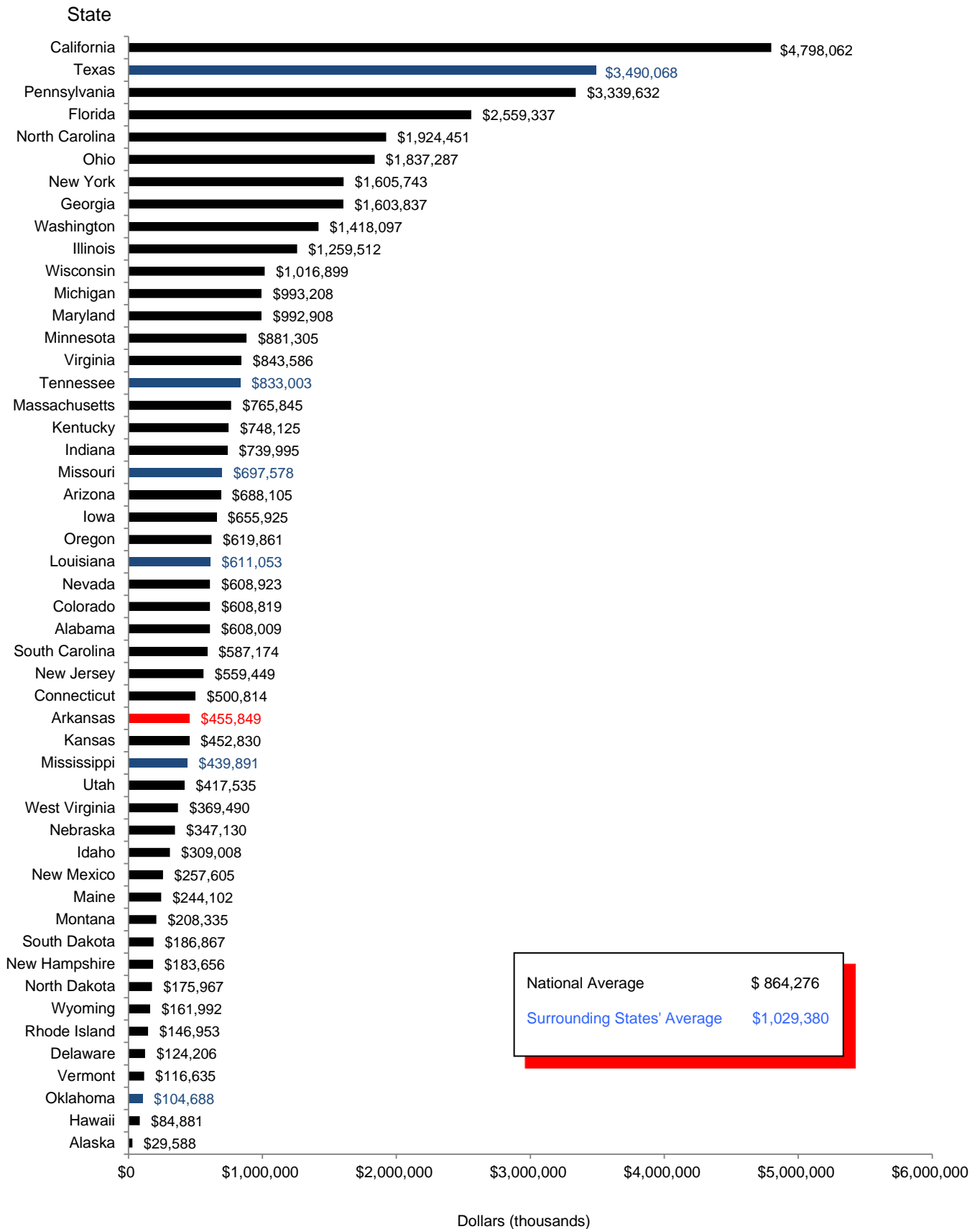
