- Processed 2,168 hot files and 411 owner/lien holder requests in the last 3 months
- Completed 45 system audits, 38 CJIS IT audits, 26 re-audits
- 236 offline searches
- 679 tokens issued in the last 3 months. 2,263 tokens issued year-to-date
- 524 active missing persons in Arkansas on the website
- 205 missing females 320 missing males for a total 525 missing persons on the NCIC report.

- Certified 966 users during the quarter with CJIS Online Security Training with a 99% pass rate.
- Certified 19,446 vendors across the nation with a 98.9% pass rate.
- Basic training: 554 users with an 94.9% pass rate.
- 785 users took the Basic Refresher, with an 86.8% pass rate.

- Current NIBRS program status: there are 388 agencies cleared to request & report.
- 13 agencies and vendors are testing to certify their RMS.

- Working with RMS and software vendors with assisting law enforcement agencies with technical reporting issues.
- 436 law enforcement agencies contacted
- 2022 Crime Statistics, uploaded on ACIC website
- Collecting additional charge codes from Administrative Office of the Courts Victims of Crimes Reports, gives victims a voice. They're used for funding and research by universities, hospitals, domestic violence, and victim advocates.

Directors Report:

Jeff Long: *"Kara's put me on a strict word count. I don't want to keep talking about the same thing, but I think the conference was outstanding. The thing I learned about it was to step back and let the team do it. My take was that next year, to stay out of it. They (ACIC staff) know what they need, and they knock it (conference planning) out the park. I received a lot of kudos emails."*

Jeff Long: *"Karen has been outstanding work with the Sheriff's Association. Buck has been giving a lot of information to the Attorney General's Office. So kudos to them."*

Jeff Long: *"Next week I'm meeting with Major Moyer. We're wanting to find a better way to streamline AFIS and ID Bureau."*

Jeff Long: *"I have a couple of awards I'd like to give. I read the perfect verse in the bible, Hebrew 3:13- 'But encourage one another daily, as long as it is called 'Today,' so that none of us may be hardened by sin's deceitfulness.'" Gabby is getting the first award for this. She came into my office about the Entertainment Committee, to keep the moral, and she took that task on. So I'd like to recognize her."*

Jeff Long: *"This one is a 20-year recognition for Shambry Wilson."*

Jeff Long: *"We're waiting on one more employee. Are there any questions? I would like to say while we wait, we had an outstanding year. We have really been pushing tokens. We'll even hand deliver them if they're local to save on postage."*

Chris Bentley: *"Mr. Director if I can ask you a question about the fish, with everything going to two-factor authentication, have you all thought of finding a way to be able to use a mobile device instead of fish?"*

Jeff Long: *"At one time we talked about that, it's called a 'soft token'. The previous director didn't want to push because you'd have to issue everyone phones, an issuing a token is cheaper than buying a phone plan."*

Chris Bentley: *"We use Duo on campus, and it's become one of the largest two-factor authentications in the world, and they do both fish and mobile devices. For folks that don't have Duo on their personal phone, then they can request a fish."*

Karen Burgess: *"Whatever you use, it has to be compatible with the Switch, with configurator. That's pretty limited with CPI, but since CJIS Policy has changed, then we're going to get with CPI and see exactly what they'll accept and what's compatible. CPI has a product called 'soft token', like Jeff was saying. There is a monthly charge on the soft tokens, and you can go directly to CPI and purchase that if you would like. But, we here at ACIC, we'll have to make that change on our Switch to make that compatible. But it is a product that CPI offers."*

Chris Bentley: *"The one thing we love about is the ease of turning it on and off. We know that when a person leaves, we're not looking for that fish later. We're not trying to turn off that fish, you're able to turn off that net user."*

Jeff Long: *"Lajunda Bean. I've always heard of people that could light up a room with a smile, but I've never actually witnessed it until I came here. I recall when I first got here, I received a complaint. But they complimented her during the entire complaint. When we had our conference, she volunteered to come over*

to the office and finish out the day because we were shorthanded. So, I'd like to recognize her for all of her hard work."

Jeff Long: "Does anyone have any questions?"

Vice Charman Ron Nichols: "I just want to say that I appreciate the field agents and everybody at ACIC. Y'all go above and beyond. We really appreciate you all. They need more money. If you need help over at the capital, I'll go with you."

Chairman Lloyd White: "I agree with what the Sheriff (Ron Nichols) said. Any other business to be brought before this board?"

Colonel Mike Hagar: "I'd like to introduce Lacy and Nick."

Cindy Murphy: "We have been very fortunate to add two new people to our team. Lacy and Nick. Lacy in particular I wanted you all to meet because she will be my team's liaison with ACIC. So, she'll be looking for ways to highlight things that you do. We'll make sure you all have her contact information. We're here to serve and support you."

Colonel Mike Hagar: "If I don't see you all before Christmas, thank you all for everything. You all have been like the highlight for me, as far as the surprise. I had no idea what ACIC did. And its all smiles whenever I come over here. You guys are great. Thank you so much for what you do. Merry Christmas."

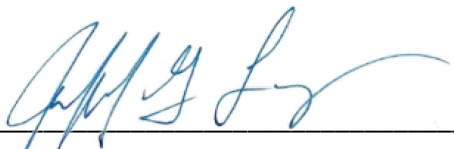
