PULASKI COUNTY, ARKANSAS.**

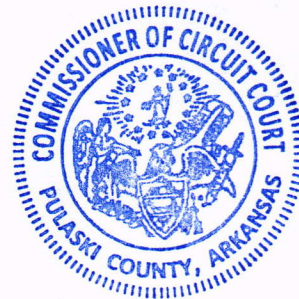
The property is more commonly known as 7005 W 43rd St, Little Rock, AR 72204.
