Technical Review Background

On October 29, 2021 the Arkansas Board of Apportionment met and introduced new versions of the House and Senate District boundaries. At the meeting the Board approved a motion for the Arkansas GIS Office to conduct a technical review of the proposed maps. The following report documents a series of changes proposed by the Office that were presented to staff of the Board for their consideration. The analysis performed by the Office was categorized into two priority levels.

Priority 1 Review Areas

These change areas represent census blocks with zero population and moving one or more blocks from one district to another district may improve compactness, contiguousness, recognize geographic barriers, or avoid splitting other levels of election geography, such as cities, precincts, or school districts, which create unnecessary ballot splits. These recommended changes improve the result and have no impact on the population variances from the target. Examples included opposite banks of lakes, or large streams moved to the center, or opposite sides of an interstate or divided highway moved to one side, or the other for consistency. During this analysis 49 areas with 0 population were identified in the Senate, and 86 for the House.

Priority 2 Review Areas

These change areas represent places where some population is affected and where moving one or more blocks from one district to another district may improve compactness, contiguousness, recognize geographic barriers, or avoid splitting other levels of election geography, such as cities, precincts, or school districts, which create unnecessary ballot splits. The intent is to align House or Senate District boundaries with existing election Geographies, School District Boundaries, City limits, County boundaries or other geographic barriers as much as possible, while minimizing the effect on the overall variance as little as possible.

Population variances between each proposed change were not iteratively tracked. This is because there were instances where a district population went up due to a change with its neighboring district on one side, and then may have gone back down due to some other population change with its other neighbor on the other side. Each proposed change only shows the total of the population in the change area itself.

Proposed changes were mindful of the variance reference charts that provided a guideline, on how much, or little that would change the variance. For example, the average of all proposed Senate District changes was 150 in population. The chart below illustrates that moving 150 population from one district to another is less than $\frac{1}{4}$ of 1% change in the variance.

These proposed changes were presented to the Board's staff with additional discussion and guidance from staff. During this analysis 26 areas with some populations were identified in the Senate, and 65 for the House.

Senate Proposed Changes

Change Type: Geographic Barriers

From: Senate 19

To: Senate 20

Description of Location: Craighead County; Area on the west side of Jonesboro. Around US Highway 63 and Craighead County Road 347.

Change Description: Proposed change moves the western boundary of Senate District 20, which is also the eastern boundary of Senate District 19, to correspond to US Highway 63. The proposed change avoids the potential ballot split in an area containing a total population of 117. This change would align House and Senate boundary along US Highway 63.

From: Senate 20

To: Senate 19

Description of Location: Craighead County; Area on the west side of Jonesboro. Around US Highway 63 and Dan Ave.

Change Description: Proposed change moves the western boundary of Senate District 20, which is also the eastern boundary of Senate District 19, to correspond to US Highway 63. The proposed change avoids the potential ballot split in an area containing a total population of 84. This change would align House and Senate boundary.

From: Senate 26

To: Senate 28

Description of Location: Franklin County; Area within the exit ramp for exit # 37 on Interstate 40 for the city of Ozark in Franklin County.

Change Description: Proposed change moves the northern boundary of Senate District 28, which is also the southern boundary of Senate District 26, to follow the north side of Interstate 40, the area within west bound off ramp exit #37. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 3. By Aligning the Districts to Interstate 40 it would increase compactness of both Senate District 26 and 28.

From: Senate 7

To: Senate 6

Description of Location: Garland County; Area south of the city of Hot Springs just west of Central Ave.

Change Description: Proposed change moves the eastern boundary of Senate District 6, which is also the western boundary of Senate District 7, to follow Central Ave. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 55. This would align Senate District 6 and 7 to Central Ave, which is also Arkansas Highway 7.

From: Senate 7 **To: Senate 6**

Description of Location: Garland County; Area south of East Grand Ave in Hot Springs City Limits and West of Gulpha Creek.

Change Description: Proposed change moves the eastern boundary of Senate District 6, which is also the western boundary of Senate District 7, in the city of Hot Springs, to follow the Gulpha Creek as the new boundary. The proposed change avoids the potential ballot split in an area containing a total population of 39. This would increase the compactness of both Senate District 6 and 7 and would follow Gulpha Creek, a geographic barrier.

From: Senate 26 **To: Senate 28**

Description of Location: Johnson County; Area is about 6 Miles west of the City of Clarksville, in Johnson County, along the north side of Interstate 4, around Exit # 47.

Change Description: Proposed change moves the northern boundary of Senate District 26, which is also the southern boundary of Senate District 28, to follow the north side of Interstate 40, around exit #47. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 75. By Aligning the Districts to Interstate 40 it would increase compactness of both Senate District 26 and 28.

From: Senate 10 **To: Senate 9**

Description of Location: Lee County; Area Due West of Marianna.

Change Description: Proposed change moves the eastern boundary of Senate District 10, which is also the western boundary of Senate District 9, just west of the city of Marianna to run the length of Lee County Road # 408. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 193. This change will increase the compactness of Senate Districts 9 and 10.

From: Senate 10 **To: Senate 9**

Description of Location: St. Francis County; Area within the Municipal boundary of Forrest city. Area bounded by North Washington Street to the East, North Division Street to the West and Part of Mississippi Ave to the South. The Northern boundary is where North Washington Street and North Division Street intersect.

Change Description: Proposed change moves the western boundary of Senate District 9, which is also the eastern boundary of Senate District 10, West to North Division Street. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 26. This change will increase the compactness of Senate Districts 9 and 10 and avoids split in precinct boundaries.

From: Senate 7 **To: Senate 6**

Description of Location: Saline County; Area on the West side of the County line North of Arkansas Highway 5.

Change Description: Proposed change moves the south boundary of Senate District 6, which is also the north boundary of Senate District 7, to follow Arkansas Highway 5. The proposed change avoids a geographic barrier and improves access in an area containing a total population of 8. This would increase consistency along Arkansas Highway 5 for both Senate District 6 and 7.

From: Senate 18 **To: Senate 24**

Description of Location: Area at the convergence of the White, Faulkner and Lonoke County Lines.

Change Description: Proposed change moves the southern boundary of Senate District 18, which is also the northern boundary of Senate District 24 from along Arkansas Highway 319 East, north to follow Cypress Bayou, thus coinciding with the southern boundary of Senate District 18 and the northern boundary of Senate District 11 to the East of both the White and Lonoke County Lines. The proposed change avoids the potential ballot split in an area containing a total population of 24. This change will increase the compactness of Senate Districts 18 and 24.

Change Type: Avoid Ballot Splits

From: Senate 34 **To: Senate 35**

Description of Location: Benton County; Area just to the west of the city of Centerton, south of Shipe Road and east of North Spring Valley Road.

Change Description: Proposed change moves the western boundary of Senate District 34, which is also the eastern boundary of Senate District 35, to correspond to the existing voting precincts. The proposed change avoids the potential ballot split in an area containing a total population of 11.

From: Senate 34 **To: Senate 33**

Description of Location: Benton County; Area within Bentonville, South of Southwest 14th Street and West of Been Road.

Change Description: The proposed change represents a multipart effort to bring both Senate Districts 33 and 34 into alignment with intersection of House Districts 10, 13 and 14. Senate and House Districts here would be coincident. The proposed change moves the West boundary of Senate District 33, which is also the eastern boundary of Senate District 34, in the city of Bentonville. The proposed change avoids the potential ballot split in an area containing a total population of 685. This would align the House and Senate and increase compactness.

From: Senate 19 **To: Senate 20**

Description of Location: Craighead County; Area on the west side of Jonesboro. Around Craighead County Road 114.

Change Description: Proposed change moves the western boundary of Senate District 20, which is also the eastern boundary of Senate District 19, to correspond to the existing voting precincts. The proposed change avoids the potential ballot split in an area containing a total population of 6.

From: Senate 19 **To: Senate 20**

Description of Location: Craighead County; Area is on the West side of the city of Jonesboro, just north of Craighead County Road 200.

Change Description: Proposed change moves the western boundary of Senate District 20, which is also the eastern boundary of Senate District 19, to following the city limits boundary of Jonesboro. The proposed change avoids the potential ballot split in an area containing a total population of 11. This change would align House and Senate boundary along city Limits of Jonesboro and avoids an additional split in precinct boundaries.

From: Senate 20 **To: Senate 19**

Description of Location: Craighead County; Area is on the south side of the city of Jonesboro just South of Southwest Drive.

Change Description: Proposed change moves the southern boundary of Senate District 20, which is also the northern boundary of Senate District 19, to following the city limits boundary of Jonesboro. The proposed change avoids the potential ballot split in an area containing a total population of 38. This change would align House and Senate boundary along city Limits of Jonesboro and avoids an additional split in precinct boundaries.

From: Senate 2 **To: Senate 7**

Description of Location: Grant County; Area to the northwest of Sheridan.

Change Description: Proposed change moves the southern boundary of Senate District 7, which is also the northern boundary of Senate District 6, to follow the existing voting precincts. The proposed change avoids the potential ballot split in an area containing a population of 9. This would align Senate District 6 and 7 to the existing precinct boundary thus decreasing precinct splits.

From: Senate 21 **To: Senate 22**

Description of Location: Lawrence County; Area on to the northwest of Hoxie and including part of the city of Hoxie.

Change Description: Proposed change moves the southern boundary of Senate District 21, which is also the northern boundary of Senate District 22, to correspond to the existing school district boundary between Lawrence County and Hoxie Districts. The proposed change avoids the potential ballot split in an area containing a total population of 450.

From: Senate 21

To: Senate 22

Description of Location: Lawrence County; Area focused on Hoxie and Walnut Ridge in Lawrence County.

Change Description: Proposed change represents a multipart effort to bring both Senate Districts 21 and 22 into alignment with House Districts 28 and 30 to minimize ballot splits. Without the proposed change the City of Hoxie would be split two different ways. Senate and House districts here would be coincident. The proposed alignment approaches from the west along the Lawrence County and Hoxie School District boundary, to the municipal boundary between Hoxie and Walnut Ridge to the intersection of Texas Street, also known as Highway 367, then heads southwest along the same road. The proposed change here exchanges 450 population north of US Highway 63, with the population described in the next proposed change. *See note.

From: Senate 22

To: Senate 21

Description of Location: Lawrence County; Area focused on Hoxie and Walnut Ridge.

Change Description: Proposed change represents a multipart effort to bring both Senate Districts 21 and 22 into alignment with House Districts 28 and 30 to minimize ballot splits. Senate and House districts here would be coincident. The proposed alignment approaches from the west along the Lawrence County and Hoxie School District boundary, to the municipal boundary between Hoxie and Walnut Ridge to the intersection of Texas Street, also known as Highway 367, then heads southwest along the same road. The proposed change here exchanges 840 population east of Highway 367, with the population described in the previous proposed change. *See note.

*NOTE: The changes described for the Hoxie and Walnut Ridge focus area represent a net change of 390 population going to District 21.

From: Senate 22

To: Senate 21

Description of Location: Lawrence County; Area is the west side of Walnut Ridge between the city limits of said city.

Change Description: Proposed change removes an outcrop of Senate District 22 along the Northeast edge, which is also the western boundary of Senate District 21, to follow the Black River, Arkansas Highway 63 and the city limits of both Black Rock and Portia. The proposed change avoids the potential ballot split in an area containing a total population of 77. This change would align the House and Senate minimize Ballot Splits.

From: Senate 21 **To: Senate 22**

Description of Location: Lawrence County; Area to the southeast of Walnut Ridge.

Change Description: Proposed change moves the southern boundary of Senate District 21, which is also the northern boundary of Senate District 22, to follow the coincide with the House Districts 28 and 30. The proposed change avoids the potential ballot split in an area containing a population of 312. This would align Senate District 21 and 22 to the House districts 28 and 30 thus decreasing precinct splits.

From: Senate 24 **To: Senate 28**

Description of Location: Newton County; Area is about 4 miles southeast of Jasper.

Change Description: Proposed change moves the northern boundary of Senate District 28, which is also the southern boundary of Senate District 24, to follow the existing section lines. Said section line being the north boundary line of Section 4, Township 15N Range 20W. The proposed change avoids the potential ballot split in an area containing a population of 1 person. This change would increase the compactness of both Senate District 24 and 28.

From: Senate 12 **To: Senate 8**

Description of Location: Pulaski County; Area just south of the North Little Rock City limit boundary along the West side of Colonel Maynard Road.

Change Description: Proposed change moves the southern boundary of Senate District 12, which is also the northern boundary of Senate District 8, just south of the existing North Little Rock City limits, north to follow said city limits. The proposed change avoids the potential ballot split in an area containing a total population of 19. This change will follow city limits, thus improving compactness in both Senate District 8 and 12 and avoids split in precinct boundaries.

From: Senate 7 **To: Senate 6**

Description of Location: Saline County; Area just Northeast of Fountain Lake.

Change Description: Proposed change moves the eastern boundary of Senate District 6, which is also the western boundary of Senate District 7, to follow the school District of Fountain Lake. This removes a split to the northeastern portion of Hot Springs Village, thus making Hot Springs Village as a community of interest entirely in Senate District 6. The proposed change avoids the potential ballot split in an area containing a total population of 178. This would align Senate District 6 and 7 to the Fountain Lake school District thus decreasing precinct splits.

From: Senate 7 **To: Senate 6**

Description of Location: Saline County; Area to the southeast of Fountain Lake.

Change Description: Proposed change moves the eastern boundary of Senate District 6, which is also the western boundary of Senate District 7, to follow the school District of Fountain Lake. The proposed change avoids the potential ballot split in an area containing a population of 8. This would align Senate District 6 and 7 to the Fountain Lake school District thus decreasing precinct splits.

From: Senate 27

To: Senate 5

Description of Location: Sebastian County; Area south of Fort Smith around the intersection of E Highway 45 and Highway 253.

Change Description: Proposed change moves the southern boundary of Senate District 27, which is also the northern boundary of Senate District 2, to correspond to the existing voting precincts. The proposed change avoids the potential ballot split in an area containing a total population of 103.

House Proposed Changes

Change Type: Compactness

From: House 38

To: House 30

Description of Location: Craighead County; West of Jonesboro, along US Highway 63.

Change Description: Proposed change moves the western boundary of House District 30, which is also the eastern boundary of House District 38, to correspond to US Highway 63. The proposed change avoids the potential ballot split. The House and Senate Districts here will be coincident. The proposed change contains a population of 117.

From: House 40

To: House 39

Description of Location: Independence County; South of Sulphur Rock.

Change Description: The proposed change would a portion of House District 40, also a shared boundary with house district 39, to follow the existing school district boundary between Cedar Ridge and Batesville School Districts. This would remove a ballot split. The proposed change contains a population of 10.

From: House 40

To: House 28

Description of Location: Independence County; west side of Batesville.

Change Description: This proposed change would move the west side of House District 28, also the east boundary of House District 40, to follow the city limits of Batesville. This would remove a ballot split. The proposed change contains a population of 8.

From: House 39

To: House 38

Description of Location: Jackson County; Along the Black River.

Change Description: The proposed change moves the Waters Store election precinct from House District 38 to House District 39 to improve the compactness of District 39. The proposed change contains a population of 116.

From: House 99 **To: House 88**

Description of Location: Miller County; city of Texarkana; the intersection of Calhoon Trl and N Rondo Rd.

Change Description: The proposed change would move a section of the city of Texarkana in Miller County on the northeast quadrant of the intersection of Calhoon Trl and N Rondo Rd from House District 99 to House District 88. This change would align the House district boundaries in this area with the Texarkana city limits. The proposed change contains a population of 11.

From: House 37 **To: House 63**

Description of Location: St Francis County; city of Widener.

Change Description: The proposed change would move the piece of the city of Widener that lies west of Highway 50 and St Francis County 400 Rd and east of the city limit from House District 37 to House District 63. This change improves the compactness of both districts. The proposed change contains a population of 19.

From: House 28 **To: House 41**

Description of Location: Stone County; area northeast of Mountain View around Country Charm Rd.

Change Description: The proposed change moves an area of Stone County northeast of the city of Mountain View containing the roads Blue Jay Way, Country Charm Rd, Jimmy Driftwood Pkwy, Misty Ln, Sands Dr, Trammell Ln, Webb Acres Dr, Whipporwill Ln and portions of Glenn Ln, Herpel Rd, Highway 5, and Old Highway 382 House District 28 to House District 41. This change aligns a portion of the House District 41 boundary with the city limits of Mountain View and improves the compactness of both districts. The proposed change contains a population of 173.

Change Type: Community of Interest

From: House 6 **To: House 26**

Description of Location: Carroll County; Green Forest; south of Main St and west of Butler Ave.

Change Description: The proposed change would move an area of the city of Green Forest in Carroll County containing the roads Compton St, Debbie Lynn St, Locust Ave, Maple Ave, Mimosa St, Mulberry St, Oak Ave, Western St, and portions of W Main St from House District 6 to House District 26. This change makes the district boundary within the city limits of Green Forest US Hwy 62(W Main St). The proposed change contains a population of 171.

From: House 42 **To: House 57**

Description of Location: Faulkner County; west side of the City of Enola.

Change Description: The proposed change moves the portion of the city of Enola in Faulkner County that was originally in House District 42 into House District 57. This puts all of the city of Enola within House District 57. The proposed change contains a population of 82.

From: House 30 **To: House 28**

Description of Location: Lawrence County; City of Sedgewick; area within the city limits northeast of US Hwy 63.

Change Description: The proposed change would move an area of the city of Sedgewick in Lawrence County from House District 30 to House District 28 to align the new House boundary with the Sedgewick city limits. The area to be moved is northeast of US Highway 63 and contains the roads Cypress St, Smith Ave and portions of Highway 228 E, Lawrence 635 Rd, N Main St, and S Main St. This change makes the district boundary within the city limits of Sedgewick. The proposed change contains a population of 43.

From: House 60 **To: House 61**

Description of Location: Prairie County; north side of the City of De Valls Bluff.

Change Description: The proposed change would move the sections of the City of De Valls Bluff. The original plan had portions of the city split between House District 60 and House District 61. This would make all of the city of De Valls Bluff within House District 61. The proposed change contains a population of 86.

Change Type: Geographic Barriers

From: House 8 **To: House 7**

Description of Location: Benton County; north of Avoca; an area east of Highway 62 and south of Sugar Creek Rd.

Change Description: The proposed change moves a portion of Benton County that is east of Highway 62, south of Sugar Creek Rd, and west of N Old Wire Rd from House District 8 to House District 7. This change makes Highway 62 the district boundary from the north side of the Avoca city limit boundary to Highway 72. The proposed change avoids a geographic barrier and improves access for a population of 111.

From: House 64 **To: House 62**

Description of Location: Desha County; an area west of the intersection of Highway 165 and 212.

Change Description: The proposed change would move a section of Pendleton Ln and Miller Ln in Desha County from House District 64 to House District 62. This change would put both roads fully within House District 62. The proposed change avoids a geographic barrier and improves access for a population of 32.

From: House 35 **To: House 37**

Description of Location: Cross County; area north of Cross 425 Rd, Cross 420 Rd and east of Highway 75.

Change Description: The proposed change would move an area of Cross County between the cities of Cherry Valley and Gilmore, which contains the roads Cross 419 Rd, Cross 421 Rd and portions of Cross 425 Rd and Highway 42 from House District 35 to House District 37 to align the House district boundary to the Cross, and Crittenden County boundary. The proposed change avoids a geographic barrier and improves access for a population of 13.

From: House 90 **To: House 91**

Description of Location: Garland County; south of the city of Hot Springs on the north side of Central Ave between Long Island Dr and Hamilton Oaks Dr.

Change Description: The proposed change would move an area of Garland County south of the city of Hot Springs that is on the north side of Central Ave between Long Island Dr and Hamilton Oaks Dr from House District 90 to House District 91. This would align both House and Senate districts to Central Avenue in this area. The proposed change avoids a geographic barrier and improves access for a population of 55.

From: House 30 **To: House 28**

Description of Location: Lawrence County; City of Sedgewick; area within the city limits northeast of US Hwy 63.

Change Description: The proposed change would move an area of the city of Sedgewick in Lawrence County from House District 30 to House District 28 to align the new House boundary with the Sedgewick city limits. The area to be moved is northeast of US Highway 63 and contains the roads Cypress St, Smith Ave and portions of Highway 228 E, Lawrence 635 Rd, N Main St, and S Main St. The proposed change avoids a geographic barrier and improves access for a population of 43.

From: House 29 **To: House 83**

Description of Location: Saline County; west of the city of Haskell along Highway 67.

Change Description: The proposed change would move an area of Saline County west of the city of Haskell bounded by Smith Loop and Highway 67 from House District 29 to House District 83. This change makes Highway 67 the House district boundary in this area. The proposed change avoids a geographic barrier and improves access for a population of 5.

From: House 42 **To: House 43**

Description of Location: Van Buren County; east of Clinton; an area bound by Perky Ln and Highway 95.

Change Description: The proposed change would move an area of Van Buren County east of Clinton bound by Perky Ln and Highway 95 from House District 42 to House District 43. This allows Highway 95 to serve as the dividing line between House District 42 and House District 43 and improves the compactness of both districts. The proposed change avoids a geographic barrier and improves access for 14.

From: House 59 **To: House 57**

Description of Location: White County; north of McRae and Garner on the northwest side of Highway 67/167.

Change Description: The proposed change would move 3 sections of White County that are north of Garner and McRae that are on the northwest side of Highway 67/167 from House District 59 to House District 57. This change makes Highway 67/167 the boundary between the House districts in this area. The section north of McRae runs north along Arrowhead Rd then east and south along Sixteenth Section Rd to Wagon Train Rd. It then follows Wagon Train Rd northeast to Highway 13 and north along the highway to Cane Creek. It then follows the creek to Highway 67/167. The section north of Garner starts where Highway 67/167 crosses Bayou Des Arc and follows Bayou Des Arc to a point north of Highway 267. From there it turns due south until it meets Highway 67/167. The proposed change avoids a geographic barrier and improves access for a population of 169.

Change Type: Avoid Ballot Splits

From: House 10 **To: House 12**

Description of Location: Benton County; Gravette; north of Deer Dr and west of W Tanyard Hollow Rd.

Change Description: The proposed change would move a portion of the city of Gravette in Benton County containing portions of Deer Dr and W Tanyard Hollow Rd between Highway 549 and Hexham Dr from House District 10 to House District 12. This proposed change would place all of Gravette within House District 12. The proposed change contains a population of 14.

From: House 14 **To: House 12**

Description of Location: Benton County; Northwest of Centerton on the east side of N Spring Valley Rd just to the south of Shipe Rd.

Change Description: The proposed change moves a portion of Benton County northwest of Centerton, which includes a portion of N Spring Valley Rd between Shipe Rd and Bethlehem Rd from House District 14 into House District 12 to align with the school district boundary. This move prevents split election ballots. The proposed change contains a population of 11.

From: House 12 **To: House 10**

Description of Location: Benton County; Bella Vista; north of Kings Lynn Ln/Belgravia Dr; west of Chelsea Ln.

Change Description: The proposed change moves a portion of the city of Bella Vista which includes Halvergate Ln, Hillborough Ln, Kenninghall Ln, Kenninghall Ln, Kings Lynn Ln, Plymouth Cir, Waveney Ln and portions of Belgravia Dr, Chelsea Rd, and Highland Rd so that the new House district boundary will align with the Gravette and Bella Vista city limit boundary in this area. This area would move from House District 12 to House District 10 and improve the population variance of both districts. The proposed change contains a population of 31.

From: House 14 **To: House 12**

Description of Location: Benton County; northwest of Centerton; the area bounded by N Spring Valley Rd, W Spring Valley Rd, Wildwood Way, and N Mt Olive Rd.

This change improves the compactness of both House districts and prevents splitting election ballots. The proposed change contains a population of 16.

From: House 16 **To: House 17**

Description of Location: Benton County; south of Highfill between Steward Rd and Bryant Rd.

Change Description: The proposed change moves a portion of Benton County south of Highfill containing portions of Bryant Rd and Steward Rd between N Gaiche Rd and Galley Hollow Rd from House District 16 to House District 17 so that the House boundary aligns with the Gentry and Siloam Springs School District boundary. This change improves the compactness of both House districts and prevents splitting election ballots. The proposed change contains a population of 25.

From: House 19 **To: House 18**

Description of Location: Benton County; Tontitown; vicinity of S Maestri Rd and Georges Ave intersection.

Change Description: The proposed change moves a portion of the city of Tontitown in Benton County containing portions of Georges Ave and S Maestri Rd from House District 19 to House District 18 so that the new House boundary will align with the shared Springdale and Tontitown city limit. Change Description: The proposed change moves a portion of Precinct 36 in the City of Bentonville south of SW 14th St, east of SW Been Rd, north of Glen Rd, and east of Greenhouse Rd, in exchange for population between the previous proposed change to allow for a house and senate district lines to become coincident in this area, thereby avoiding election splits. Change Description: The proposed change would move an area of the city of Hoxie in Lawrence County containing the roads Anna Dr, Esther Dr, Morrison St, NW Alice St, NW Annie St, NW Broad St, NW Detroit St, NW Edgar St, NW Horseshoe Dr, NW Lawrence St, NW Randolph St, NW Sullivan St, Ray Dr, Rose Garden St, SW Tedder Dr and portions of Highway 63B N, Industrial Dr, Midway Rd, NW Texas St, and SW Memphis St from House District 30 to House District 28 to align with the new Senate boundary and school district boundary. Change Description: The proposed change moves territory near the intersection of Four Corners Rd and Blue Mountain Rd from House District 24 to House District 23 to align with the Lincoln and Prairie Grove School District boundaries, thereby avoiding an election split. The proposed change contains a population of 10.

Description of Location: Washington County; South of Prairie Grove.

Change Description: Proposed change moves the western boundary of House District 23, which is also the eastern boundary of House District 24, to correspond to the Lincoln and Prairie Grove School Districts. From: House 22 **To: House 23**

Description of Location: Washington County; between Farmington and Greenland.

Change Description: The proposed change would move an area of Washington County between Farmington, Fayetteville, and Greenland and a portion of W Pearl Ln from House District 22 into House District 23 so that the new House boundary aligns with the school district boundary. This change would prevent splitting election ballots. The proposed change contains a population of 3.
